AN ACT

Making emergency supplemental appropriations for the fiscal year ending September 30, 1993, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, to pro-
5 vide emergency supplemental appropriations for the fiscal

1 year ending September 30, 1993, and for other purposes,

12 For an additional amount for “Buildings and facili-
 13 ties”, \$37,569,000, to remain available until the end of
 14 fiscal year 1993.

17 For an additional amount for “Salaries and ex-

16 For an additional amount for “National forest sys-
17 tem”, to be used for maintenance, repairs, rehabilita-

19 \$150,000,000, to remain available for obligation until the
20 end of fiscal year 1993.

21 CONSTRUCTION

22 For an additional amount for “Construction”, to be
23 used for recreation facility and trail construction,
24 \$37,844,000, to remain available for obligation until the
25 end of fiscal year 1993.

1 DEPARTMENT OF ENERGY

2 ENERGY CONSERVATION

3 For enhanced “Energy conservation” activities,
4 \$100,778,000, to remain available until expended, of
5 which \$28,177,000 shall be for implementation of titles
6 III, IV, and V of the Energy Policy Act of 1992 (Public
7 Law 102-486), including no less than \$25,677,000 for the
8 acquisition of alternative-fuel vehicles for the Federal fleet
9 and for the conversion of existing vehicles in the Federal
10 fleet to alternative fuels: *Provided*, That such funds shall
11 only be used to pay the cost differential between the alter-
12 native-fuel vehicle and the same model of vehicle in its
13 conventional-fuel design, not to exceed \$3,500 for any ve-
14 hicle; and of which \$18,784,000 shall be for full funding
15 for a one-time special award of grants under the Institu-
16 tional Conservation Program; and of which \$46,961,000
17 shall be for grants to States for the Weatherization Assist-
18 ance Program; and of which \$5,635,000 shall be available
19 to the Federal Energy Management Program for ex-
20 panded training, site audit, and other support functions;
21 and of which \$1,221,000 shall be available to establish a
22 fund administered by the Federal Energy Management
23 Program to provide financial assistance for cost-effective
24 energy efficiency improvements to facilities of any Federal
25 agencies other than the Departments of Defense, Energy,

1 and Veterans Affairs, and the General Services
2 Administration.

7 DEPARTMENT OF LABOR
8 EMPLOYMENT AND TRAINING ADMINISTRATION
9 TRAINING AND EMPLOYMENT SERVICES

10 For an additional amount for “Training and Employ-
11 ment Services”, \$1,000,000,000, to carry into effect the
12 Job Training Partnership Act, of which \$10,500,000 is
13 for activities under part D of title IV of such Act, and
14 \$989,500,000 for activities under part B of title II of such
15 Act: *Provided*, That of the funds provided herein for part
16 B of title II, \$18,500,000 shall be for territories and enti-
17 ties specified by section 252(a) of the Act, which shall be
18 allotted based on the allotment methodology made to such
19 areas under Public Law 102-170, of which \$6,000,000
20 must be used only to provide academic enrichment activi-
21 ties, as defined by the Secretary: *Provided further*, That
22 of the funds provided herein for part B of title II, each
23 State and service delivery area shall be allotted an amount
24 which, when added to its allotment from Public Law 102-
25 170, results in a total amount which is 25 percent above

1 the total of its allotments under Public Laws 101–517 and
2 102–302, except that such allotment to each State and
3 service delivery area under this proviso shall be reduced
4 by the amount of its unexpended carryover as of January
5 30, 1993: *Provided further*, That of the funds provided
6 herein for part B of title II, \$294,000,000 shall be for
7 academic enrichment, as defined by the Secretary, and
8 shall be allotted among States and allocated among service
9 delivery areas on the basis of the relative number of eco-
10 nomically disadvantaged youth, as defined in section 262
11 of the Act, in such areas as compared to the total number
12 of economically disadvantaged youth in all States and
13 service delivery areas within each State, respectively, and
14 only to provide academic enrichment activities: *Provided*
15 *further*, That funds made available herein for academic en-
16 richment shall not be used to supplant other Federal funds
17 for existing academic services or activities, and services
18 shall be maintained at least at the level of funding used
19 for these purposes during the summer of 1992: *Provided*
20 *further*, That funds provided herein for part B of title II
21 which are not allotted under the first three provisos under
22 this heading shall be allotted to service delivery areas con-
23 taining the 100 cities with the largest population of eco-
24 nomically disadvantaged youth, as defined in section 262
25 of the Act, on the basis of the relative number of economi-

1 cally disadvantaged youth in each of the service delivery
 2 areas as compared to total economically disadvantaged
 3 youth in all such service delivery areas: *Provided further,*
 4 That data related to economically disadvantaged youth
 5 herein shall be based on 1990 Census data: *Provided fur-*
 6 *ther,* That of the funds provided herein, except for the
 7 \$294,000,000 expressly allotted for academic enrichment
 8 activities, service delivery areas may transfer up to 10 per-
 9 cent to the program under part C of title II of the Act,
 10 if such transfer is approved by the Governor: *Provided fur-*
 11 *ther,* That up to 3 percent of each State's allotment for
 12 academic enrichment may be reserved for State adminis-
 13 tration, oversight, and support of a State practitioner's
 14 network.

15 Funds provided in Public Law 102-394 for part B
 16 of title III of such Act shall be available for obligation
 17 upon enactment of this Act.

18 COMMUNITY SERVICE EMPLOYMENT FOR OLDER
 19 AMERICANS

20 For an additional amount for "Community service
 21 employment for older Americans", \$32,131,000, of which
 22 \$25,062,000 is for national grants or contracts with public
 23 agencies and public or private nonprofit organizations
 24 under section 506(a)(1)(A) of the Older Americans Act
 25 of 1965, as amended; and of which \$7,069,000 is for
 26 grants to States under section 506(a)(3) of said Act.

1 STATE UNEMPLOYMENT INSURANCE AND EMPLOYMENT
 2 SERVICE OPERATIONS
 3 (INCLUDING TRANSFER OF FUNDS)

4 For an additional amount for “State unemployment
 5 insurance and employment service operations”,
 6 \$14,300,000, to remain available until expended, which
 7 shall be expended from the Employment Security Adminis-
 8 tration account in the Unemployment Trust Fund, to fund
 9 worker profiling activities and for oversight of employment
 10 programs: *Provided*, That of the funds provided herein up
 11 to \$2,700,000 may be transferred to the Program Admin-
 12 istration account.

13 ADVANCES TO THE UNEMPLOYMENT TRUST FUND AND
 14 OTHER FUNDS

15 For an additional amount for “Advances to the un-
 16 employment trust fund and other funds”, \$4,000,000,000,
 17 to remain available until September 30, 1994.

18 DEPARTMENT OF HEALTH AND HUMAN
 19 SERVICES

20 HEALTH RESOURCES AND SERVICES ADMINISTRATION
 21 HEALTH RESOURCES AND SERVICES

22 For an additional amount to carry out title XXVI of
 23 the Public Health Service Act, \$200,000,000.

1 NATIONAL INSTITUTES OF HEALTH

2 NATIONAL LIBRARY OF MEDICINE

3 For an additional amount to carry out section 301
4 and title IV of the Public Health Service Act with respect
5 to high-performance computing applications, \$9,392,000.

6 ASSISTANT SECRETARY FOR HEALTH

7 OFFICE OF THE ASSISTANT SECRETARY FOR HEALTH

8 (INCLUDING TRANSFER OF FUNDS)

9 For an additional amount for the “Office of the As-
10 sistant Secretary for Health” for carrying out childhood
11 immunization activities under title III and subtitle 1 of
12 title XXI of the Public Health Service Act, \$300,000,000,
13 of which \$282,800,000 shall be transferred to the Centers
14 for Disease Control and Prevention, of which \$4,200,000
15 shall be transferred to the National Institute of Allergy
16 and Infectious Diseases, and of which \$7,000,000 shall
17 be transferred to the Food and Drug Administration.

18 SOCIAL SECURITY ADMINISTRATION

19 PAYMENTS TO THE SOCIAL SECURITY TRUST FUNDS

20 For an additional amount for “Payments to the So-
21 cial Security Trust Funds” to reimburse the trust funds
22 for administrative expenses to carry out sections 9704 and
23 9706 of the Internal Revenue Code of 1986, \$10,000,000,
24 to remain available until expended.

1 SUPPLEMENTAL SECURITY INCOME

2 For an additional amount for “Supplemental security
3 income” for payment to the Social Security trust funds
4 for administrative expenses, \$150,000,000; and, in addi-
5 tion, to provide for making, after June 15 of the current
6 fiscal year, benefits payments to individuals under title
7 XVI of the Social Security Act, for unanticipated costs
8 incurred for the current fiscal year, such sums as may be
9 necessary.

10 LIMITATION ON ADMINISTRATIVE EXPENSES

11 For an additional amount, \$302,000,000, of which
12 \$142,000,000 shall be derived from the Federal Old-Age

16 sections 9704 and 9706 of the Internal Revenue Code of
17 1986.

19 CHILDREN AND FAMILIES SERVICES PROGRAMS

20 For an additional amount for carrying out the Head
21 Start Act, \$500,000,000.

22 DEPARTMENT OF EDUCATION

23 COMPENSATORY EDUCATION FOR THE DISADVANTAGED

24 For an additional amount for concentration grants
25 under section 1006 of the Elementary and Secondary
26 Education Act of 1965, \$500,000,000, which shall become

1 available upon enactment and shall remain available to
2 local educational agencies through September 30, 1993:
3 *Provided*, That the number of children counted for section
4 1006(a) shall be the same as counted for 1993 section
5 1005 basic grants: *Provided further*, That no State shall
6 receive less than \$250,000 of such funds: *Provided further*,
7 That such funds shall only be made available by State edu-
8 cational agencies to local educational agencies upon assur-
9 ance that at least 80 per centum of such funds shall be
10 liquidated by such agencies by September 30, 1993: *Pro-*
11 *vided further*, That such funds shall be used for activities
12 that benefit educationally deprived children as authorized
13 under section 1011 and other related activities such as
14 food services, school health services, arts education, and
15 transportation, without regard to whether such activities
16 are otherwise authorized under such section: *Provided fur-*
17 *ther*, That a State educational agency may reallocate any
18 portion of such funds that are not able to be used by local
19 educational agencies in the State to other such agencies
20 on the basis of their relative needs, as determined by the
21 State educational agency, without regard to section
22 1403(b)(2) of such Act: *Provided further*, That such funds
23 may be used only to supplement, and not to supplant any
24 other funds, including other funds made available under
25 chapter 1 of title I of such Act or under any other Federal

1 program: *Provided further*, That such funds, and the ac-
2 tivities carried out with such funds, shall not be subject
3 to or considered in applying section 1006(a)(1)(B)–(D),
4 1019, 1020, 1021, or 1432(b) of such Act or to section
5 412(b) of the General Education Provisions Act: *Provided*
6 *further*, That such funds shall not be treated as funds ap-
7 propriated, allocated, or received under chapter 1 of title
8 I of the Elementary and Secondary Education Act of 1965
9 for the purpose of section 1403, 1404, 1405, or
10 1432(b)(1) of such Act: *Provided further*, That such funds
11 shall not be taken into account for purposes of determin-
12 ing the allocation of funds for any fiscal year under any
13 Federal program.

14 For an additional amount for grants to the 50 States,
15 the District of Columbia, and the Commonwealth of
16 Puerto Rico, to carry out subpart 1 of part A of chapter
17 1 of title I of the Elementary and Secondary Education
18 Act of 1965, \$234,805,000, which shall be allocated to
19 such jurisdictions, notwithstanding any other provision of
20 law, so that all counties that, under title III of Public Law
21 102–394, are allocated less than 92 per centum of the
22 amount they were allocated under such subpart for fiscal
23 year 1992 shall be allocated, under Public Law 102–394
24 plus this additional amount, 92 per centum of the amount
25 such counties received under such subpart for fiscal year

1 1992: *Provided*, That such allocations to States shall be
 2 ratably reduced if necessary: *Provided further*, That each
 3 State shall distribute its portion of such funds to local
 4 educational agencies in the State so that all such agencies
 5 that, under title III of Public Law 102-394, are receiving
 6 less than 92 per centum of the amount they received under
 7 such subpart for fiscal year 1992 shall receive, under Pub-
 8 lic Law 102-394 plus this additional amount, an amount
