Mrs. MORELLA introduced the following bill; which was referred to the Committee on Post Office and Civil Service

A BILL

To amend title 5, United States Code, to extend the Federal Physicians Comparability Allowance Act of 1978, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSIONS.**

4 (a) EXTENSION OF AUTHORITY.—

5 (1) IN GENERAL.—The second sentence of sec-
6 tion 5948(d) of title 5, United States Code, is
7 amended to read as follows: “No agreement shall be
8 entered into under this section later than September
9 30, 1997, nor shall any agreement cover a period of
10 service extending beyond September 30, 1999.”.

1 (2) ADVANCE APPROPRIATIONS REQUIRED.—
2 Any service agreement entered into on or after the
3 date of the enactment of this Act pursuant to sec-
4 tion 5948 of title 5, United States Code, as amended
5 by paragraph (1), shall be effective only to such ex-
6 tent or in such amounts as are provided in advance
7 in appropriation Acts.

8 (3) RULE OF CONSTRUCTION.—The amend-
9 ments made by this section shall not be construed to
10 authorize additional or supplemental appropriations
11 for the fiscal year ending September 30, 1993.

12 (b) EXTENSION OF REPEALER.—Section 3 of the
13 Federal Physicians Comparability Allowance Act of 1978
14 (5 U.S.C. 5948 note) is amended by striking “September
15 30, 1995” and inserting “September 30, 1999”.

16 **SEC. 2. TECHNICAL AMENDMENTS.**

17 (a) AMENDMENT TO PUBLIC LAW 100-140.—Effec-
18 tive as of October 27, 1987, section 1 of Public Law 100-
19 140 (101 Stat. 830) is amended by adding at the end the
20 following:

21 “(c) EXTENSION OF REPEALER.—Section 3 of the
22 Federal Physicians Comparability Allowance Act of 1978
23 (5 U.S.C. 5948 note) is amended by striking ‘September
24 30, 1989’ and inserting ‘September 30, 1992’.”.

1 (b) AMENDMENT TO PUBLIC LAW 101-420.—Effec-
2 tive as of October 13, 1990, Public Law 101-420 (104
3 Stat. 908) is amended—

4 (1) by inserting “(a)” after “That”; and

5 (2) by adding at the end the following:

6 “(b) Section 3 of the Federal Physicians Comparabil-
7 ity Allowance Act of 1978 (5 U.S.C. 5948 note) is amend-
8 ed by striking ‘September 30, 1992’ and inserting ‘Sep-
9 tember 30, 1995’.”.

10 **SEC. 3. ORDER OF AMENDMENTS.**

11 For purposes of applying the amendments made by
12 this Act—

13 (1) the provisions of section 2(a) shall be treat-
14 ed as having been enacted immediately before the
15 provisions of section 2(b); and

16 (2) the provisions of section 2(b) shall be treat-
17 ed as having been enacted immediately before the
18 provisions of section 1.
