**AMENDMENTS**

***In the Senate of the United States,***

*August 19 (legislative day, August 18), 1994.*

*Resolved*, That the bill from the House of Representatives (H.R. 1779) entitled “An Act to designate the facility of the United States Postal Service located at 401 South Washington Street in Chillicothe, Missouri, as the ‘Jerry L. Litton United States Post Office Building’”, do pass with the following

**AMENDMENTS:**

1 Page 2, after line 5, insert:

2 ***SEC. 3. TRAVEL AND TRANSPORTATION EXPENSES OF CER-***  
3 ***TAIN FEDERAL CAREER APPOINTEES.***

4 *(a) IN GENERAL.—Section 5724(a)(3) of title 5,*  
5 *United States Code, is amended by striking out “November*  
6 *27, 1988” and inserting in lieu thereof “November 17,*  
7 *1988”.*

8 *(b) EFFECTIVE DATE.—The amendment made by sub-*  
9 *section (a) shall take effect as if included in the Technical*

1 *and Miscellaneous Civil Service Amendments Act of 1992*  
2 *(Public Law 102–378; 106 Stat. 1346; 5 U.S.C. 1101 note).*

3 **SEC. 4. TRAVEL AND TRANSPORTATION EXPENSES FOR**  
4 **FAMILY MEMBERS OF CAREER APPOINTEES.**

5 *Paragraph (3) of section 5724(a) of title 5, United*  
6 *States Code, is amended to read as follows:*

7 *“(3) upon the separation (or death in service) of*  
8 *a career appointee, as defined in section 3132(a)(4)*  
9 *of this title, the travel expenses of that individual (if*  
10 *applicable), the transportation expenses of the imme-*  
11 *diate family of such individual, and the expenses of*  
12 *moving (including transporting, packing, crating,*  
13 *temporarily storing, draying, and unpacking) the*  
14 *household goods of such individual and personal ef-*  
15 *fects not in excess of eighteen thousand pounds net*  
16 *weight, to the place where the individual will reside*  
17 *(or, in the case of a career appointee who dies in serv-*  
18 *ice or who dies after separating but before the travel,*  
19 *transportation, and moving is completed, to the place*  
20 *where the family will reside) within the United*  
21 *States, its territories or possessions, the Common-*  
22 *wealth of Puerto Rico, or the areas and installations*  
23 *in the Republic of Panama made available to the*  
24 *United States pursuant to the Panama Canal Treaty*  
25 *of 1977 and related agreements, as described in sec-*

1        *tion 3(a) of the Panama Canal Act of 1979, if such*  
2        *individual—*

3                *“(A) during or after the five years proceed-*  
4                *ing eligibility to receive an annuity under sub-*  
5                *chapter III of chapter 83, or of chapter 84 of this*  
6                *title, has been transferred in the interest of the*  
7                *Government from one official station to another*  
8                *for permanent duty as a career appointee in the*  
9                *Senior Executive Service or as a director under*  
10               *section 4103(a)(8) of title 38 (as in effect on No-*  
11               *vember 17, 1988); and*

12               *“(B) is eligible to receive an annuity upon*  
13               *such separation (or, in the case of death in serv-*  
14               *ice, met the requirements for being considered el-*  
15               *igible to receive an annuity, as of date of death)*  
16               *under the provisions of subchapter III of chapter*  
17               *83 or chapter 84 of this title.”.*

18        **SEC. 5. EFFECTIVE DATE.**

19               *(a) IN GENERAL.—This Act and the amendment made*  
20               *by this Act shall take effect on October 1, 1994, or, if later,*  
21               *the date of the enactment of this Act.*

22               *(b) SPECIAL RULE.—*

23               *(1) IN GENERAL.—Under regulations prescribed*  
24               *by the President or his designee, an agency shall, as*  
25               *appropriate, pay or make reimbursement for any*

1     *moving expenses which would be payable under the*  
2     *provisions of section 5724(a)(3) of title 5, United*  
3     *States Code, as amended by section 1 (but which*  
4     *would not have been payable under such provisions,*  
5     *as last in effect before being so amended).*

6             (2) *APPLICABILITY.—The moving expenses to*  
7     *which this subsection applies are those incurred by*  
8     *the family of an individual who died—*

9                 (i) *before separating from Government serv-*  
10     *ice; and*

11                (ii) *during the period beginning on Janu-*  
12     *ary 1, 1994, and ending on the effective date of*  
13     *this Act.*

14             (3) *CONDITION.—Payment or reimbursement*  
15     *under this subsection may not be made except upon*  
16     *appropriate written application submitted within 12*  
17     *months after date on which the regulations referred to*  
18     *in paragraph (1) take effect.*

Amend the title so as to read: “An Act to designate the facility of the United States Postal Service located at 401 South Washington Street in Chillicothe, Missouri, as the ‘Jerry L. Litton United States Post Office Building’, and to authorize travel and transportation expenses for

certain Federal career appointees, and for other purposes.”.
