AN ACT

To authorize appropriations for the Martin Luther King, Jr. Federal Holiday Commission, to extend such Commission, and to support the planning and performance of national service opportunities in conjunction with the Federal legal holiday honoring the birthday of Martin Luther King, Jr.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “King Holiday and
5 Service Act of 1994”.

1 **SEC. 2. MARTIN LUTHER KING, JR. FEDERAL HOLIDAY**
2 **COMMISSION.**

3 The Act entitled “An Act to establish a commission
4 to assist in the first observance of the Federal legal holi-
5 day honoring Martin Luther King, Jr.”, approved August
6 27, 1984 (36 U.S.C. 169j and following) is amended—

7 (1) in section 3(1) by inserting “(including
8 service opportunities)” after “activities”;

9 (2) in section 4(a) by striking “and” at the end
10 of paragraph (5), by striking the period at the end
11 of paragraph (6) and inserting “; and”, and by add-
12 ing at the end the following:

13 “(7) the Chief Executive Officer of the Corpora-
14 tion for National and Community Service, appointed
15 under section 193 of the National and Community
16 Service Act of 1990 (42 U.S.C. 12651c).”;

17 (3) in section 6(a) by striking “maximum rate
18 of pay payable for grade GS-18 of the General
19 Schedule under section 5332” and inserting “rate of
20 pay for level IV of the Executive Schedule under sec-
21 tion 5315”;

22 (4) by amending section 7 to read as follows:

23 “SEC. 7. There are authorized to be appropriated to
24 carry out this Act—

25 “(1) \$300,000 for fiscal year 1995;

26 “(2) \$350,000 for fiscal year 1996;

1 “(2) \$400,000 for fiscal year 1997;

2 “(2) \$450,000 for fiscal year 1998; and

3 “(2) \$500,000 for fiscal year 1999.”;

4 (5) in section 8 by inserting after “under this
5 Act” the following: “or under the National and
6 Community Service Act of 1990”; and

7 (6) in section 9 by striking “April 20, 1994”
8 and inserting “September 30, 1999”.

9 **SEC. 3. MARTIN LUTHER KING, JR., SERVICE DAY.**

10 (a) **ADDITIONAL CORPORATION ACTIVITY TO SUP-**
11 **PORT NATIONAL SERVICE.**—Section 198 of the National
12 and Community Service Act of 1990 (42 U.S.C. 12653)
13 is amended by adding at the end the following new sub-
14 section:

15 “(s) **MARTIN LUTHER KING, JR., SERVICE DAY.**—

16 “(1) **ASSISTANCE.**—The Corporation may make
17 grants to eligible entities described in paragraph (2)
18 to pay for the Federal share of the cost of planning
19 and carrying out service opportunities in conjunction
20 with the Federal legal holiday honoring the birthday
21 of Martin Luther King, Jr. Such service opportuni-
22 ties shall consist of activities reflecting the life and
23 teachings of Martin Luther King, Jr., such as co-
24 operation and understanding among racial and eth-
25 nic groups, nonviolent conflict resolution, equal eco-

1 nomic and educational opportunities, and social jus-
2 tice.

3 “(2) ELIGIBLE ENTITIES.—Any entity other-
4 wise eligible for assistance under the national serv-
5 ices laws shall be eligible to receive a grant under
6 this subsection.

7 “(3) CONSULTATION.—In making grants under
8 this subsection, the Corporation shall consult with
9 the Martin Luther King, Jr. Federal Holiday Com-
10 mission established under section 2 of Public Law
11 98–399 (36 U.S.C. 169j–1).

12 “(4) FEDERAL SHARE.—Grants provided under
13 this subsection to an eligible entity to support the
14 planning and carrying out of a service opportunity
15 in conjunction with the Federal legal holiday honor-
16 ing the birthday of Martin Luther King, Jr., to-
17 gether with all other Federal funds used to plan or
18 carry out the service opportunity, may not exceed 30
19 percent of the cost of planning and carrying out the
20 service opportunity.

21 “(5) CALCULATION OF ENTITY CONTRIBU-
22 TIONS.—In determining the non-Federal share of
23 the costs of planning and carrying out a service op-
24 portunity supported by a grant under this sub-
25 section, the Corporation shall consider in-kind con-

1 tributions (including facilities, equipment, and serv-
2 ices) made to plan or carry out the service oppor-
3 tunity.”.

4 (b) TECHNICAL AND CONFORMING AMENDMENTS.—

5 (1) REFERENCE TO REPEALED SECTION.—Sec-
6 tion 101(a)(3) of the National and Community Serv-
7 ice Trust Act of 1993 (Public Law 103–82; 107
8 Stat. 788) is amended by striking “through 136”
9 and inserting “through 135”.

10 (2) INCORRECT REFERENCE TO ACT.—Section
11 203(a)(3) of the National and Community Service
12 Trust Act of 1993 (Public Law 103–82; 107 Stat.
13 891) is amended by striking “Act of 1993” and in-
14 sserting “Act of 1990”.

15 (3) DESCRIPTION OF NATIONAL SERVICE PAR-
16 TICIPANTS.—Section 137(c) of the National and
17 Community Service Act of 1990 (42 U.S.C.
18 12591(c)), as added by section 101(b) of the Na-
19 tional and Community Service Trust Act of 1993
20 (Public Law 103–82; 107 Stat. 809), is amended by
21 striking “subsection (a)(5)(A)” and inserting “sub-
22 section (a)(5)”.

23 (4) EDUCATIONAL AWARD ELIGIBILITY RE-
24 QUIREMENTS.—Section 146(a) of the National and
25 Community Service Act of 1990 (42 U.S.C.

1 12602(a)), as added by section 102(a) of the Na-
2 tional and Community Service Trust Act of 1993
3 (Public Law 103–82; 107 Stat. 818), is amended by
4 striking the second paragraph (3).

5 (5) CIVILIAN COMMUNITY CORPS.—

6 (A) USE OF INCORRECT TERM.—Section
7 155(e) of the National and Community Service
8 Act of 1990 (42 U.S.C. 12615(e)), as redesign-
9 nated by section 104(b)(3) of the National and
10 Community Service Trust Act of 1993 (Public
11 Law 103–82; 107 Stat. 840), is amended by
12 striking “CORPS” and inserting “CAMPS”.

13 (B) REFERENCE TO SECTION.—Subsection
14 (c)(2)(C)(i) of section 159 of the National and
15 Community Service Act of 1990 (42 U.S.C.
16 12619), as amended by section 104(e)(2)(E)(ii)
17 of the National and Community Service Trust
18 Act of 1993 (Public Law 103–82; 107 Stat.
19 847), is amended by striking “section section
20 162(a)(2)” and inserting “section 162(a)(2)”.

21 (C) CROSS REFERENCE.—Section
22 162(a)(1)(B)(ii) of the National and Commu-
23 nity Service Act of 1990 (42 U.S.C.
24 12622(a)(1)(B)(ii)), as redesignated by section
25 104(b)(3) of the National and Community Serv-

1 ice Trust Act of 1993 (Public Law 103–82; 107
2 Stat. 840), is amended by striking “section
3 4462 of the National Defense Authorization Act
4 for Fiscal Year 1993” and inserting “section
5 1143a of title 10, United States Code”.

6 (6) PUNCTUATION.—Section 198(q)(1) of the
7 National and Community Service Act of 1990 (42
8 U.S.C. 12653(q)(1)), as added by section 104(c) of
9 the National and Community Service Trust Act of
10 1993 (Public Law 103–82; 107 Stat. 840), is
11 amended by striking “1995” and inserting “1995,”.

12 (7) REDESIGNATED PARAGRAPH.—Subsection
13 (b)(6) of section 103 of the Domestic Volunteer
14 Service Act of 1973 (42 U.S.C. 4953), as redesign-
15 ated by section 323(b)(3) of the National and Com-
16 munity Service Trust Act of 1993 (Public Law 103–
17 82; 107 Stat. 900), is amended by striking “(6)”
18 and inserting “(5)”.

19 (8) SUBPARAGRAPH INDENTATION.—Subsection
20 (c)(1)(F) of section 103 of the Domestic Volunteer
21 Service Act of 1973 (42 U.S.C. 4953), as added by
22 section 323(c)(1)(D) of the National and Commu-
23 nity Service Trust Act of 1993 (Public Law 103–82;
24 107 Stat. 900), is amended by moving the left mar-
25 gin two ems to the left.

1 (9) CORRECT EXECUTION OF AMENDMENT.—
2 Section 224 of the Domestic Volunteer Service Act
3 of 1973 (42 U.S.C. 5024) is amended by striking
4 “volunteer projects for older Americans” and insert-
5 ing “National Senior Volunteer Corps projects”.

6 (10) EFFECTIVE DATES.—

7 (A) IN GENERAL.—Except as provided in
8 subparagraph (B), the amendments made by
9 this subsection shall take effect on the date of
10 the enactment of this Act.

11 (B) RETROACTIVE EFFECTIVE DATE.—The
12 amendments made by paragraphs (1) and (2)
13 shall take effect as of October 1, 1993.
