A BILL

To extend the temporary suspension of duty on 1-[1-((4-Chloro-2-(trifluoromethyl)-phenyl)imino)-2-propoxyethyl]-1-H-imidazole, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF EXISTING SUSPENSION OF**
4 **DUTY ON 1-[1-((4-CHLORO-2-(TRIFLUORO-**
5 **METHYL)-PHENYL)IMINO)-2-PROPOXYETHYL]-**
6 **1-H-IMIDAZOLE.**

7 (a) IN GENERAL.—Heading 9902.31.07 of the Har-
8 monized Tariff Schedule of the United States is amended
9 by—

1 (1) inserting “(triflumizole)” after “1-[1-((4-
2 Chloro-2-(trifluoromethyl)-phenyl)imino)-2-propoxy-
3 ethyl]-1-H-imidazole”;

4 (2) striking “12/31/92” and inserting “12/31/
5 98”.

6 (b) EFFECTIVE DATE.—

7 (1) IN GENERAL.—The amendments made by
8 subsection (a) apply with respect to goods entered,
9 or withdrawn from warehouse for consumption, on
10 or after the 15th day after the date of the enact-
11 ment of this Act.

12 (2) RETROACTIVE APPLICATION TO CERTAIN
13 ENTRIES.—Notwithstanding section 514 of the Tar-
14 iff Act of 1930 (19 U.S.C. 1514) or any other provi-
15 sion of law, upon proper request filed with the ap-
16 propriate customs officer before the 90th day after
17 the date of the enactment of this Act, any entry, or
18 withdrawal from warehouse for consumption, of any
19 goods described in heading 9902.31.07 (as amended
20 by subsection (a)(1)) of the Harmonized Tariff
21 Schedule of the United States that was made—

22 (A) after December 31, 1992; and

23 (B) before the 15th day after the date of
24 the enactment of this Act;

1 shall be liquidated or reliquidated as though such
2 entry or withdrawal occurred on the 15th day after
3 the date of the enactment of this Act.
