Mr. GILMAN (for himself, Mr. BONIOR, Mr. HOKE, and Mr. HINCHEY) introduced the following bill; which was referred to the Committee on the Judiciary

---

## A BILL

To recognize the organization known as the Ukrainian  
American Veterans, Incorporated.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. CHARTER.**

4       The Ukrainian American Veterans, Incorporated, or-  
5       ganized and incorporated under the laws of the State of  
6       New York, is hereby recognized and granted a Federal  
7       charter.

8       **SEC. 2. POWERS.**

9       The corporation shall have only the powers granted  
10      to it through its bylaws and articles of incorporation filed

1 in the States in which it is incorporated and subject to  
2 the laws of such States.

3 **SEC. 3. PURPOSES.**

4 The purposes of the corporation are those provided  
5 in its articles of incorporation and include a commitment,  
6 on a national basis, to—

7 (1) preserve, protect and defend the Constitu-  
8 tion of the United States;

9 (2) commemorate the wars, campaigns, and  
10 military actions of the United States in order to re-  
11 flect respect, honor, and tribute for the dead and the  
12 surviving veterans;

13 (3) give individuals throughout the Nation a  
14 greater understanding of and appreciation for the  
15 sacrifices of the people who participated in any mili-  
16 tary action on behalf of individuals throughout the  
17 United States;

18 (4) stimulate, to the highest degree possible, the  
19 interest of the entire Nation in the problems of vet-  
20 erans, their widows, and orphans;

21 (5) collect, edit, publish, and preserve records  
22 and mementos of patriotic service of veterans of the  
23 Armed Forces of the United States;

1           (6) foster the association of veterans of Ukrain-  
2           ian descent who have served in the Armed Forces of  
3           the United States; and

4 **SEC. 8. RESTRICTIONS.**

5           (a) USE OF INCOME AND ASSETS.—No part of the  
6           income or assets of the corporation may inure to any mem-  
7           ber, officer, or director of the corporation or be distributed  
8           to any such person during the life of this charter. No pro-  
9           vision in this subsection may be construed to prevent the  
10          payment of reasonable compensation to the officers and  
11          employees of the corporation or reimbursement for actual  
12          necessary expenses in amounts approved by the board of  
13          directors.

14          (b) LOANS.—The corporation may not make any loan  
15          to any member, officer, director, or employee of the cor-  
16          poration.

17          (c) POLITICAL ACTIVITY.—The corporation, any offi-  
18          cer, or director of the corporation, acting as such officer  
19          or director, may not contribute to, support, or otherwise  
20          participate in any political activity or in any manner at-  
21          tempt to influence legislation.

22          (d) ISSUANCE OF STOCK AND PAYMENT OF DIVI-  
23          DENDS.—The corporation may not issue any shares of  
24          stock or declare or pay any dividends.

1 (e) CLAIMS OF FEDERAL APPROVAL.—The corpora-  
2 tion may not claim the approval of the Congress or the  
3 authorization of the Federal Government for any of its  
4 activities.

5 (f) CORPORATE STATUS.—The corporation shall  
6 maintain its status as a corporation organized and incor-  
7 porated under the laws of the State of New York.

8 (g) CORPORATE FUNCTION.—The corporation shall  
9 function as an educational, patriotic, civic, and historical  
10 organization under the laws of the States in which it is  
11 incorporated.

12 **SEC. 9. LIABILITY.**

13 The corporation shall be liable for the acts of its offi-  
14 cers, directors, employees, and agents whenever the offi-  
15 cers, directors, employees, and agents act within the scope  
16 of their authority.

17 **SEC. 10. MAINTENANCE AND INSPECTION OF BOOKS AND**  
18 **RECORDS.**

19 (a) BOOKS AND RECORDS OF ACCOUNT.—The cor-  
20 poration shall keep correct and complete books and  
21 records of account and shall keep minutes of any proceed-  
22 ing of the corporation involving any of its members, the  
23 board of directors, or any committee having authority  
24 under the board of directors.

1 (b) NAMES AND ADDRESSES OF MEMBERS.—The  
2 corporation shall keep, at its principal office, a record of  
3 the names of all members having the right to vote in any  
4 proceeding of the corporation.

5 (c) RIGHT TO INSPECT BOOKS AND RECORDS.—All  
6 books and records of the corporation may be inspected by  
7 any member having the right to vote, or by any agent or  
8 attorney of such member, for any proper purpose, at any  
9 reasonable time.

10 (d) APPLICATION OF STATE LAW.—No provision of  
11 this section may be construed to contravene any applicable  
12 State law.

13 **SEC. 11. AUDIT OF FINANCIAL TRANSACTIONS.**

14 The first section of the Act entitled “An Act to pro-  
15 vide for audit of accounts of private corporations estab-  
16 lished under the Federal law”, approved August 30, 1964  
17 (36 U.S.C. 1101), is amended by adding at the end of  
18 the following:

19 “Ukrainian American Veterans, Incorporated.”.

20 **SEC. 12. ANNUAL REPORT.**

21 The corporation shall annually submit to the Con-  
22 gress a report concerning the activities of the corporation  
23 during the preceding fiscal year. The annual report shall  
24 be submitted at the same time as is the report of the audit

1 required by section 11. The report shall not be printed  
2 as a public document.

3 **SEC. 13. RESERVATION OF RIGHT TO AMEND OR REPEAL**

4 **CHAPTER.**

5 The right to amend or repeal this Act is expressly  
6 reserved to the Congress.

7 **SEC. 14. DEFINITIONS.**

8 For purposes of this Act—

9 (1) the term “corporation” means the Ukrain-  
10 ian American Veterans, Incorporated; and

11 (2) the term “State” means any of the several  
12 States, the District of Columbia, the Commonwealth  
13 of Puerto Rico, the Commonwealth of the Northern  
14 Mariana Islands, the Virgin Islands, Guam, Amer-  
15 ican Samoa, the Trust Territories of the Pacific Is-  
16 lands, or any other territory or possessions of the  
17 United States.

18 **SEC. 15. TAX EXEMPT STATUS.**

19 The corporation shall maintain its status as an orga-  
20 nization exempt from taxation as provided in the Internal  
21 Revenue Code of 1986.

22 **SEC. 16. TERMINATION.**

23 The charter granted in this Act shall expire if the  
24 corporation fails to comply with any provisions of this Act.
