1 **SECTION 1. SHORT TITLE AND STATUTORY REFERENCE.**

2 (a) SHORT TITLE.—This Act may be cited as the
3 “Fiscal Year ~~1994~~ *Years 1994 and 1995* BLM Authoriza-
4 tion Act”.

5 (b) STATUTORY REFERENCE.—As used in this Act,
6 the term “the Act” means the Federal Land Policy and
7 Management Act of 1976 (43 U.S.C. 1701 et seq.).

8 **SEC. 2. AUTHORIZATION AND FUTURE REAUTHORIZA-**
9 **TIONS.**

10 (a) AUTHORIZATION.—Section 318(a) of the Act (43
11 U.S.C. 1748(a)) is amended by striking out “October 1,
12 1978” and by inserting in lieu thereof “October 1, ~~1994~~
13 *1995*”.

14 (b) FUTURE REAUTHORIZATIONS.—Section 318(b)
15 of the Act is amended by striking “May 15, 1977, and
16 not later than May 15 of each second even numbered year
17 thereafter” and by inserting in lieu thereof “January 1,
18 1994, and January 1 of each second odd-numbered year
19 thereafter”.

Amend the title so as to read: “A bill to amend the Federal Land Policy and Management Act of 1976 to authorize appropriations for programs, functions, and activities of the Bureau of Land Management, Department of the Interior, for fiscal years 1994 and 1995, and for other purposes.”.
