A BILL

To authorize certain atmospheric, weather, and satellite programs and functions of the National Oceanic and Atmospheric Administration, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “National Oceanic and*
5 *Atmospheric Administration Atmospheric and Satellite*
6 *Program Authorization Act of 1993”.*

7 **TITLE I—AUTHORIZATION OF**
8 **APPROPRIATIONS**

9 **SEC. 101. NATIONAL WEATHER SERVICE.**

10 *(a) OPERATIONS AND RESEARCH.—There are author-*
11 *ized to be appropriated to the Secretary of Commerce (in*
12 *this Act referred to as the “Secretary”) to enable the Na-*
13 *tional Oceanic and Atmospheric Administration to carry*
14 *out the operations and research duties of the National*
15 *Weather Service, \$473,256,000 for fiscal year 1994 and*
16 *\$492,185,000 for fiscal year 1995. Such duties include mete-*
17 *orological, hydrological, and oceanographic public*
18 *warnings and forecasts, as well as applied research in sup-*
19 *port of such warnings and forecasts.*

20 *(b) SYSTEMS ACQUISITION.—There are authorized to*
21 *be appropriated to the Secretary to enable the National Oce-*

1 *anic and Atmospheric Administration to carry out the pub-*
2 *lic warning and forecast systems duties of the National*
3 *Weather Service, \$76,299,000 for fiscal year 1994 and*
4 *\$71,115,000 for fiscal year 1995. Such duties include the*
5 *development, acquisition, and implementation of major*
6 *public warning and forecast systems. None of the funds au-*
7 *thorized under this subsection shall be used for the purposes*
8 *for which funds are authorized under section 102(b) of the*
9 *National Oceanic and Atmospheric Administration Author-*
10 *ization Act of 1992 (Public Law 102–567). No funds may*
11 *be expended for Next Generation Doppler Weather Radar*
12 *(NEXRAD) until the requirements of paragraph (2)(A) or*
13 *(B) of such section 102(b) have been fulfilled by the Sec-*
14 *retary. None of the funds for NEXRAD authorized by such*
15 *section 102(b)(2)(A) or (B) shall be expended, subject to an-*
16 *ual review, for a particular NEXRAD installation site un-*
17 *less such site appears on page D–10, D–11, or D–12 of the*
18 *National Implementation Plan for Modernization of the*
19 *National Weather Service, required under section 703 of the*
20 *National Oceanic and Atmospheric Administration Author-*
21 *ization Act of 1992 (Public Law 102–567), for fiscal year*
22 *1994, or unless such funds are to be used only for spare*
23 *parts, not installation at a particular site.*

24 (c) CONSTRUCTION OF WEATHER FORECAST OF-
25 FICES.—There are authorized to be appropriated to the Sec-

1 *retary to enable the National Oceanic and Atmospheric Ad-*
2 *ministration to carry out construction, repair, and modi-*
3 *fication activities relating to new and existing weather fore-*
4 *cast offices, \$62,784,000 for fiscal year 1994 and*
5 *\$14,739,000 for fiscal year 1995. Such activities include*
6 *planning, design, and land acquisition related to such*
7 *offices.*

8 **SEC. 102. ATMOSPHERIC RESEARCH.**

9 (a) *CLIMATE AND AIR QUALITY RESEARCH.*—

10 (1) *IN GENERAL.*—*There are authorized to be ap-*
11 *propriated to the Secretary to enable the National*
12 *Oceanic and Atmospheric Administration to carry*
13 *out its climate and air quality research duties,*
14 *\$105,922,000 for fiscal year 1994 and \$138,737,000*
15 *for fiscal year 1995. Such duties include interannual*
16 *and seasonal climate research and long-term climate*
17 *and air quality research.*

18 (2) *CLIMATE AND GLOBAL CHANGE.*—*Of the*
19 *sums authorized under paragraph (1), \$66,902,000*
20 *for fiscal year 1994 and \$84,573,000 for fiscal year*
21 *1995 are authorized to be appropriated for the pur-*
22 *poses of studying climate and global change, includ-*
23 *ing global observations, monitoring, and data and in-*
24 *formation management relating to the study of*
25 *changes in the Earth's climatic system, and fun-*

1 *damental research on oceanic and atmospheric proc-*
2 *esses critical to climate prediction and diagnostics.*

3 *(b) ATMOSPHERIC PROGRAMS.—There are authorized*
4 *to be appropriated to the Secretary to enable the National*
5 *Oceanic and Atmospheric Administration to carry out its*
6 *atmospheric research duties, \$42,103,000 for fiscal year*
7 *1994 and \$52,980,000 for fiscal year 1995. Such duties in-*
8 *clude research for developing improved prediction capabili-*
9 *ties for atmospheric processes, as well as solar-terrestrial*
10 *research and services.*

11 **SEC. 103. NATIONAL ENVIRONMENTAL SATELLITE, DATA,**
12 **AND INFORMATION SERVICE.**

13 *(a) SATELLITE OBSERVING SYSTEMS.—There are au-*
14 *thorized to be appropriated to the Secretary to enable the*
15 *National Oceanic and Atmospheric Administration to carry*
16 *out its satellite observing systems duties, \$206,383,000 for*
17 *fiscal year 1994 and \$264,890,000 for fiscal year 1995, ex-*
18 *cept that no funds may be expended for Geostationary Oper-*
19 *ational Environmental Satellite until the requirements of*
20 *section 105(d)(2) (A) or (B) of the National Oceanic and*
21 *Atmospheric Administration Authorization Act of 1992*
22 *(Public Law 102–567) have been fulfilled by the Secretary.*
23 *Such duties include spacecraft procurement, launch, and*
24 *associated ground station system changes involving polar*
25 *orbiting and geostationary environmental satellites, as well*

1 *as the operation of such satellites. None of the funds author-*
2 *ized under this subsection shall be used for the purposes for*
3 *which funds are authorized under section 105(d) of the Na-*
4 *tional Oceanic and Atmospheric Administration Authoriza-*
5 *tion Act of 1992 (Public Law 102-567).*

6 (b) *ENVIRONMENTAL DATA AND INFORMATION SERV-*
7 *ICES.—There are authorized to be appropriated to the Sec-*
8 *retary to enable the National Oceanic and Atmospheric Ad-*
9 *ministration to carry out its environmental data and infor-*
10 *mation services duties, \$34,068,000 for fiscal year 1994 and*
11 *\$41,227,000 for fiscal year 1995. Such duties include cli-*
12 *mate data services, geophysical data services, and environ-*
13 *mental assessment and information services.*

14 **SEC. 104. PROGRAM SUPPORT.**

15 (a) *ADMINISTRATION AND SERVICES.—There are au-*
16 *thorized to be appropriated to the Secretary for Administra-*
17 *tion and Services, \$73,319,000 for fiscal year 1994 and*
18 *\$76,252,000 for fiscal year 1995.*

19 (b) *AIRCRAFT SERVICES.—There are authorized to be*
20 *appropriated to the Secretary for Aircraft Services and Air-*
21 *craft Critical Safety and Instrumentation, \$9,495,000 for*
22 *fiscal year 1994 and \$9,875,000 for fiscal year 1995.*

23 **[SEC. 105. LIMITATION ON APPROPRIATIONS.**

24 **[***Notwithstanding any other provision of this Act, no*
25 *funds are authorized to be appropriated for any fiscal year*

1 *after fiscal year 1995 for carrying out the programs for*
2 *which funds are authorized by this Act.]*

3 **TITLE II—MISCELLANEOUS**
4 **PROVISIONS**

5 **SEC. 201. STRATEGIC PLAN FOR ENVIRONMENTAL RE-**
6 **SEARCH LABORATORIES.**

7 *(a) ASSESSMENT.—The Secretary shall conduct an as-*
8 *essment of the long-term role and mission of the Environ-*
9 *mental Research Laboratories of the National Oceanic and*
10 *Atmospheric Administration and the relevance of the re-*
11 *search conducted therein to issues of global and national*
12 *importance. In conducting such assessment, the Secretary*
13 *shall take into consideration—*

14 *(1) the adequacy of resources provided to support*
15 *the missions of the Environmental Research Labora-*
16 *tories;*

17 **(2) the ability of the Environmental**
18 **Research Laboratories to provide re-**
19 **search support for the coastal and ocean**
20 **management and regulatory responsibil-**
21 **ities of the National Oceanic and Atmos-**
22 **pheric Administration;**

23 **[(2)] (3) the capacity of the Environmental**
24 **Research Laboratories to process and disseminate**
25 **environmental data and information collected and**

1 processed, or expected to be collected and processed,
2 by the National Oceanic and Atmospheric Adminis-
3 tration and other appropriate Federal departments
4 and agencies;

5 **[(3)] (4)** *the mission of the Environmental Re-*
6 *search Laboratories to provide solar-terrestrial serv-*
7 *ices to the Nation;*

8 **[(4)] (5)** *the ability of the Environmental Re-*
9 *search Laboratories to provide continued support for*
10 *the modernization of weather services;*

11 **[(5)] (6)** *the responsibilities of the Environ-*
12 *mental Research Laboratories to monitor, assess, and*
13 *predict changes in the Earth's climate;*

14 **[(6)] (7)** *the capability of the Environmental*
15 *Research Laboratories to integrate and interpret sci-*
16 *entific data in order to provide information useful to*
17 *policy makers for responding to national and global*
18 *environmental concerns;*

19 **[(7)] (8)** *the operational efficiency and effec-*
20 *tiveness of the Environmental Research Laboratories;*
21 **[and]**

22 **(9) the interaction of the Environ-**
23 **mental Research Laboratories with the**
24 **academic community and the ability of**
25 **Joint and Cooperative Institutes to im-**

1 **prove the quality and effectiveness of re-**
2 **search;**

3 **(10) the number, location, and geo-**
4 **graphic distribution of the Environ-**
5 **mental Research Laboratories; and**

6 **[(8)] (11)** *any other issues that the Secretary*
7 *may identify.*

8 **(b) COMPREHENSIVE STRATEGIC PLAN.**—*Not later*
9 *than 1 year after the date of enactment of this Act, the Sec-*
10 *retary shall develop and submit to the Committee on Com-*
11 *merce, Science, and Transportation of the Senate and the*
12 *Committee on Science, Space, and Technology* **and the**
13 **Committee on Merchant Marine and Fisheries**
14 *of the House of Representatives a comprehensive strategic*
15 *plan, based on the assessment conducted under subsection*
16 *(a), to modernize and improve the role and mission of the*
17 *Environmental Research Laboratories of the National Oce-*
18 *anic and Atmospheric Administration. The assessment con-*
19 *ducted under subsection (a) shall be submitted along with*
20 *such plan.*

21 **SEC. 202. HYDROLOGICAL RESEARCH AND FLOOD FORE-**
22 **CAST MODERNIZATION REPORT.**

23 **(a) IN GENERAL.**—*Not later than 6 months after the*
24 *date of enactment of this Act, the Secretary, in consultation*
25 *with the heads of other appropriate Federal agencies, shall*

1 *prepare and submit to the Committee on Commerce,*
2 *Science, and Transportation of the Senate and the Commit-*
3 *tee on Science, Space, and Technology of the House of Rep-*
4 *resentatives a report identifying the actions required to im-*
5 *prove the hydrological research programs and to modernize*
6 *the Flood Forecasting System of the National Weather*
7 *Service.*

8 (b) *REPORT CONTENTS.*—*The report required under*
9 *subsection (a) shall include consideration of—*

10 (1) *current, planned, and potential technological*
11 *improvements in the collection of observational*
12 *hydrological data;*

13 (2) *use of additional satellite remote-sensing*
14 *data and airborne surveys, including those systems*
15 *operated by other Federal agencies, for hydrological*
16 *data collection;*

17 (3) *improvements in data analysis and computer*
18 *modeling in support of flood forecasts and pre-*
19 *dictions; and*

20 (4) *full integration of the River Forecast Centers*
21 *in the National Weather Service Modernization Plan.*

22 ***[SEC. 203. NOTICE OF REPROGRAMMING.***

23 ***[(a) IN GENERAL.***—*The Secretary shall provide notice*
24 *to the Committee on Commerce, Science, and Transpor-*
25 *tation of the Senate and to the Committee on Science,*

1 *Space, and Technology of the House of Representatives, not*
2 *less than 15 days before reprogramming funds available for*
3 *a program, project, or activity of the National Oceanic and*
4 *Atmospheric Administration in an amount greater than the*
5 *lesser of \$250,000 or 5 percent of the total funding of such*
6 *program, project, or activity, if the reprogramming—*

7 **【***(1) augments an existing program, project, or*
8 *activity;*

9 **【***(2) reduces by 5 percent or more (A) the fund-*
10 *ing for an existing program, project, or activity, or*
11 *(B) the numbers of personnel therefor as approved by*
12 *Congress; or*

13 **【***(3) results from any general savings from a re-*
14 *duction in personnel which would result in a change*
15 *in an existing program, project, or activity.*

16 **【***(b) NOTICE OF REORGANIZATION.—The Secretary*
17 *shall provide notice to the Committee on Commerce,*
18 *Science, and Transportation of the Senate and the Commit-*
19 *tee on Science, Space, and Technology of the House of Rep-*
20 *resentatives not later than 15 days before any major reorga-*
21 *nization of any program, project, or activity of the National*
22 *Oceanic and Atmospheric Administration.***】**

23 **SEC. [204.] 203. SENSE OF CONGRESS.**

24 *It is the sense of Congress that any transfers of Na-*
25 *tional Weather Service employees from field offices neces-*

1 *sitated by the National Implementation Plan for Mod-*
2 *ernization of the National Weather Service be carried out*
3 *in a manner that will not result in the degradation of serv-*
4 *ices in the service area of such field office.*
