***In the Senate of the United States,***

*Resolved*, That the bill from the House of Representatives (H.R. 3167) entitled “An Act to extend the emergency unemployment compensation program, to establish a system of worker profiling, and for other purposes” do pass with the following

1 **(1)**Page 11, line 2, strike out [1994’’.] and insert:

4 **SEC. 9. REDUCTION OF FEDERAL FULL-TIME EQUIVALENT**  
5 **POSITIONS.**

6 (a) *DEFINITION.*—For purposes of this section, the  
7 term “agency” means an Executive agency as defined under  
8 section 105 of title 5, United States Code, but does not in-  
9 clude the General Accounting Office.

10 (b) *LIMITATIONS ON FULL-TIME EQUIVALENT POSI-*  
11 *TIONS.*—The President, through the Office of Management  
and Budget (in consultation with the Office of Personnel

1 Management), shall ensure that the total number of full-  
2 time equivalent positions in all agencies shall not exceed—

3 (1) 2,095,182 during fiscal year 1994;

4 (2) 2,044,100 during fiscal year 1995;

5 (3) 2,003,846 during fiscal year 1996;

6 (4) 1,963,593 during fiscal year 1997;

7 (5) 1,923,339 during fiscal year 1998; and

8 (6) 1,883,086 during fiscal year 1999;

9 (c) *MONITORING AND NOTIFICATION.*—The Office of  
10 Management and Budget, after consultation with the Office  
11 of Personnel Management, shall—

12 (1) continuously monitor all agencies and make  
13 a determination on the first date of each quarter of  
14 each applicable fiscal year of whether the require-  
15 ments under subsection (b) are met; and

16 (2) notify the President and the Congress on the  
17 first date of each quarter of each applicable fiscal  
18 year of any determination that any requirement of  
19 subsection (b) is not met.

20 (d) *COMPLIANCE.*—If at any time during a fiscal year,  
21 the Office of Management and Budget notifies the President  
22 and the Congress that any requirement under subsection (b)  
23 is not met, no agency may hire any employee for any posi-  
24 tion in such agency until the Office of Management and  
25 Budget notifies the President and the Congress that the total

1 *number of full-time equivalent positions for all agencies*  
2 *equals or is less than the applicable number required under*  
3 *subsection (b).*

4 (e) *WAIVER.—Any provision of this section may be*  
5 *waived upon—*

6 (1) *a determination by the President of the exist-*  
7 *ence of war or a national security requirement; or*

8 (2) *the enactment of a joint resolution upon an*  
9 *affirmative vote of three-fifths of the Members of each*  
10 *House of the Congress duly chosen and sworn.*

11 **(2)**Page 11, after line 2, insert:

12 ***SEC. 10. LIMITATION ON ELIGIBILITY FOR EMERGENCY UN-***  
13 ***EMPLOYMENT COMPENSATION.***

14 *Notwithstanding any other provision of law, the*  
15 *amendments made by sections 2 and 8 of this Act shall not*  
16 *apply to any individual whose taxable income (as defined*  
17 *in section 63 of the Internal Revenue Code of 1986) for any*  
18 *taxable year ending in 1992 exceeds \$120,000.*
