A BILL

To prohibit the transfer or possession of semiautomatic
assault weapons, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Semiautomatic Assault
5 Weapon Violence Prevention Act of 1993”.

6 **SEC. 2. PROHIBITION OF SEMIAUTOMATIC ASSAULT WEAP-**
7 **ONS.**

8 (a) DEFINITIONS.—Section 921(a) of title 18, United
9 States Code, is amended—

1 (1) in paragraph (28) by striking “‘semiauto-
2 matic rifle’ means any repeating rifle” and inserting
3 “‘semiautomatic firearm’ means a repeating fire-
4 arm”; and

6 paragraph:

7 “(29) The term ‘semiautomatic assault weapon’—

8 “(A) means—

9 “(i) any of the semiautomatic firearms

21 “(i) any of the firearms known as—

22 “(I) Remington Model 1100 shotgun;

23 “(II) Remington Model 7400 rifle;

24 “(III) Mossberg Model 5500 shotgun;

25 “(IV) HK Model 300 rifle;

1 “(V) Marlin Model 9 camp carbine;

2 “(VI) Browning High-Power rifle; or

3 “(VII) Remington Nylon 66 auto
4 loading rifle;

5 “(ii) a firearm that is a manually operated
6 bolt action firearm;

7 “(iii) a lever action firearm;

8 “(iv) a slide action firearm; or

9 “(v) a firearm that has been rendered per-
10 manently inoperable.”.

11 (b) PROHIBITION.—Section 922 of title 18, United
12 States Code, is amended by adding at the end the follow-
13 ing new subsection:

14 “(s)(1) Except as provided in paragraph (2), it shall
15 be unlawful for a person to transfer or possess a semiauto-
16 matic assault weapon.

17 “(2) This subsection does not apply with respect to—

18 “(A) a transfer to or by, or possession by or
19 under the authority of the United States or a de-
20 partment or agency of the United States or a State
21 or a department, agency, or political subdivision of
22 a State;

23 “(B) a lawful transfer or lawful possession of a
24 semiautomatic assault weapon that was lawfully pos-
25 sessed before the effective date of this subsection or,

1 in the case of a semiautomatic firearm that the Sec-
2 retary designates as a semiautomatic assault weapon
3 pursuant to section 931, before the date on which
4 the designation is made; or

5 “(C) the transfer or possession of a semiauto-
6 matic assault weapon by a licensed manufacturer or
7 licensed importer for the purposes of testing or ex-
8 perimentation authorized by the Secretary.”.

9 (c) DESIGNATION OF SEMIAUTOMATIC ASSAULT
10 WEAPONS.—

11 (1) IN GENERAL.—Chapter 44 of title 18, Unit-
12 ed States Code, is amended by adding at the end the
13 following new section:

14 **“§931. Designation of semiautomatic assault weapons**

15 “(a) IN GENERAL.—Not later than 180 days after
16 the date of enactment of this section, and annually there-
17 after, the Secretary, in consultation with the Attorney
18 General, shall determine whether any other semiautomatic
19 firearm (other than a firearm described in section
20 921(a)(29)(B)) should be designated as a semiautomatic
21 assault weapon in addition to those previously designated
22 by section 921(a)(29)(A) or by the Secretary under this
23 section.

24 “(b) CRITERIA.—(1) The Secretary shall by regula-
25 tion designate as a semiautomatic assault weapon a rifle,

1 pistol, or shotgun that is a semiautomatic firearm and
2 that is described in paragraph (2), (3), (4), or (5).

3 “(2) A replica or duplicate in any caliber of a semi-
4 automatic firearm described in section 921(a)(29)(A)(i) is
5 a semiautomatic assault weapon.

6 “(3) A rifle that is a semiautomatic firearm is a semi-
7 automatic assault weapon if it—

8 “(A) is not generally recognized as being par-
9 ticularly suitable for or readily adaptable to sporting
10 purposes;

11 “(B) has an ability to accept a detachable mag-
12 azine; and

13 “(C) has at least 2 of the following characteris-
14 tics:

15 “(i) A folding or telescoping stock.

16 “(ii) A pistol grip that protrudes conspicu-
17 ously beneath the action of the weapon.

18 “(iii) A bayonet mount.

19 “(iv) A flash suppressor or threaded barrel
20 designed to accommodate a flash suppressor.

21 “(v) A grenade launcher.

22 “(4) A pistol that is a semiautomatic firearm is a
23 semiautomatic assault weapon if it—

1 “(A) is not generally recognized as being par-
2 ticularly suitable for or adaptable to sporting pur-
3 poses; and

4 “(B) has an ability to accept a detachable mag-
5 azine; and

6 “(C) has at least 2 of the following characteris-
7 tics:

8 “(i) An ammunition magazine that at-
9 taches to the pistol outside of the pistol grip.

10 “(ii) A threaded barrel capable of accept-
11 ing a barrel extender, flash suppressor, forward
12 hand grip, or silencer.

13 “(iii) A shroud that is attached to or par-
14 tially or completely encircles the barrel and that
15 permits the shooter to hold the firearm with the
16 second hand without being burned.

17 “(iv) A manufactured weight of 50 ounces
18 or more when the pistol is unloaded.

19 “(v) A semiautomatic version of an auto-
20 matic firearm.

21 “(5) A shotgun that is a semiautomatic firearm is
22 a semiautomatic assault weapon if it—

23 “(A) is not generally recognized as being par-
24 ticularly suitable for or adaptable to sporting pur-
25 poses; and

1 “(B) has at least 2 of the following characteris-
2 tics:

3 “(i) A folding or telescoping stock.

4 “(ii) A pistol grip that protrudes conspicu-
5 ously beneath the action of the weapon.

6 “(iii) A fixed magazine capacity in excess
7 of 6 rounds.

8 “(iv) An ability to accept a detachable
9 magazine.”.

10 (2) TECHNICAL AMENDMENT.—The chapter
11 analysis for chapter 44 of title 18, United States
12 Code, is amended by adding at the end the following
13 new item:

 “931. Designation of semiautomatic assault weapons.”.

14 (d) PENALTIES.—Section 924(a)(1)(B) of title 18,
15 United States Code, is amended by striking “or 922(q)”
16 and inserting “922 (q), (r), or (s)”.

17 (e) IDENTIFICATION MARKINGS FOR SEMIAUTOMATIC
18 ASSAULT WEAPONS.—Section 923(i) of title 18, United
19 States Code, is amended by adding at the end the follow-
20 ing new sentence: “The serial number of a semiautomatic
21 assault weapon shall clearly show if the weapon was manu-
22 factured or imported after the effective date of this sen-
23 tence.”.
