Mr. RICHARDSON introduced the following bill; which was referred to the
Committee on Natural Resources

A BILL

To transfer a parcel of land to the Taos Pueblo Indians
of New Mexico.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. LAND TRANSFER.**

4 (a) TRANSFER.—The parcel of land described in sub-
5 section (b) is hereby transferred without consideration to
6 the Secretary of the Interior to be held in trust for the
7 Pueblo of Taos. Such parcel shall be part of the Pueblo
8 de Taos Reservation and shall be managed in accordance
9 with section 4 of the Act of May 31, 1933 (Chapter 45,
10 48 Stat. 108), as amended by Public Law 91-550 (84
11 Stat. 1473).

1 (b) LAND DESCRIPTION.—The parcel of land re-
2 ferred to in subsection (a) is a parcel of land situated with-
3 in sections 25, 26, 35, and 36, Township 27 North, Range
4 14 East, New Mexico Principal Meridian, within the
5 Wheeler Peak Wilderness Area, Carson National Forest,
6 Taos County, New Mexico, being more particularly de-
7 scribed as follows:

8 Beginning at the Northeast Corner of Taos
9 Pueblo Tract C; whence the U.S.C. and G.S. tri-
10 angulation station "WHEELER" bears N.

24 638.00 feet to top of a peak; thence N. 33°58'26"
25 W., 1,044.00 feet along ridge top; thence N.

1 05°32'26" W., 990.00 feet to top of Lew Wallace
2 Peak; thence N. 39°24'26" W., 1,238.00 feet along
3 ridge top; thence N. 26°07'26" W., 1,081.00 feet
4 continuing along ridge top between National Forest
5 and Taos Pueblo Reservation; thence N. 01°38'34"
6 E., 1,145.00 feet to top of a peak; thence N.
7 49°37'26" W., 812.00 feet along ridge top; thence
8 N. 34°12'26" W., 1,355.00 feet; thence N.
9 16°35'26" W., 594.00 feet to top of Old Mike Peak;
10 thence N. 61°45'26" W., 1,100,000 feet to top of
11 ridge; thence N. 47°26'26" W., 200.00 feet to top of
12 ridge; thence N. 60°03'26" W., 920.00 feet to top of
13 ridge; thence N. 65°15'26" W., 400.00 feet to top of
14 Simpson Peak; thence S. 49°59'16" W., 751.57 feet
15 to point of beginning, containing an area of 764.33
16 acres.

17 (c) AMENDMENT OF MAP.—As soon as practicable
18 after enactment of this Act, the Secretary of Agriculture
19 shall file a map and legal description of the Wheeler Peak
20 Wilderness as modified by subsection (a) with the Com-
21 mittee on Natural Resources of the House of Representa-
22 tives and with the Committee on Energy and Natural Re-
23 sources of the Senate. The map and description shall be
24 on file and available for public inspection in the Office of

1 the Chief of the Forest Service, United States Department
2 of Agriculture.
