3 **SECTION 1. REPEAL OF INCREASE IN EARNED INCOME TAX**

4 **CREDIT AND IN PRESIDENTIAL ELECTION**

5 **CAMPAIGN FUND CHECKOFF.**

6 (a) REPEAL OF INCREASE IN EARNED INCOME TAX

7 CREDIT.—Section 13131 of the Revenue Reconciliation

8 Act of 1993 is hereby repealed and the Internal Revenue

9 Code of 1986 shall be applied and administered as if such

1 section (and the amendments made by such section) had
2 not been enacted.

3 (b) REPEAL OF INCREASE IN PRESIDENTIAL ELEC-
4 TION CAMPAIGN FUND CHECKOFF.—Section 13441 of the
5 Revenue Reconciliation Act of 1993 is hereby repealed and
6 the Internal Revenue Code of 1986 shall be applied and
7 administered as if such section (and the amendments
8 made by such section) had not been enacted.

9 **SEC. 2. REPEAL OF MORATORIUM ON COLLECTION OF CER-**
10 **TAIN ALLOWANCES IN AMENDMENTS MADE**
11 **BY THE OMNIBUS BUDGET RECONCILIATION**
12 **ACT OF 1993.**

13 Section 13716 of the Omnibus Budget Reconciliation
14 Act of 1993 (42 U.S.C. 627 note) is hereby repealed.

15 **SEC. 3. REVERSAL OF CERTAIN 1993 RECONCILIATION ACT**
16 **AMENDMENTS RELATING TO THE FOOD**
17 **STAMP PROGRAM.**

18 (a) AMENDMENTS TO THE FOOD STAMP ACT OF
19 1977.—The Food Stamp Act of 1977 (7 U.S.C. 2011 et
20 seq.) is amended—

21 (1) in section 5(g)(2) by striking “a level” and
22 all that follows through “\$50”, and inserting
23 “\$4,500”,

24 (2) in section 17 by striking subsection (k), and

25 (3) in section 19(a)(1)(A)—

1 (A) by striking “\$1,097,000,000” and in-
2 serting “\$1,091,000,000”, and

3 (B) by striking “\$1,143,000,000” and in-
4 serting “\$1,133,000,000”.

5 (b) REPEALERS.—Chapter 3 of title XIII of the Om-
6 nibus Budget Reconciliation Act of 1993 (Public Law 103-
7 66; 107 Stat. 672) is amended—

8 (1) by striking sections 13911, 13912, 13913,
9 13914, 13915, 13916, 13921, 13922, 13924, 13931,
10 and 13932, and

11 (2) in section 13971(b)—

12 (A) by striking paragraphs (3), (5), and
13 (6), and

14 (B) in paragraph (4) by striking “Sec-
15 tions” and all that follows through “13931,
16 and”, and inserting “Section”.

17 (c) CONFORMING AMENDMENT.—Section 13901(b)
18 of the Omnibus Budget Reconciliation Act of 1993 (Public
19 Law 103-66; 107 Stat. 672) is amended in the table of
20 contents by striking the items relating to sections 13911,
21 13912, 13913, 13914, 13915, 13916, 13921, 13922,
22 13924, 13931, and 13932.
