## AN ACT

To authorize expenditures for fiscal year 1995 for the operation and maintenance of the Panama Canal, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “Panama Canal Com-  
5        mission Authorization Act, Fiscal Year 1995”.

1 **SEC. 2. AUTHORIZATION OF EXPENDITURES.**

2 (a) OPERATION, MAINTENANCE, AND IMPROVE-  
3 MENT.—Except as specified in subsection (b), the Panama  
4 Canal Commission is authorized to make such expendi-  
5 tures within the limits of funds and borrowing authority  
6 available to it in accordance with law, and to make such  
7 contracts and commitments, without regard to fiscal year  
8 limitations, and to be derived from the Panama Canal Re-  
9 volving Fund, as may be necessary under the Panama  
10 Canal Act of 1979 (22 U.S.C. 3601 et seq.), for the oper-  
11 ation, maintenance, and improvement of the Panama  
12 Canal for fiscal year 1995.

13 (b) ADMINISTRATIVE EXPENSES.—For fiscal year  
14 1995, the Panama Canal Commission is authorized to  
15 make expenditures from the Panama Canal Revolving  
16 Fund for administrative expenses, not to exceed  
17 \$50,030,000, including—

18 (1) not to exceed \$11,000 for official reception  
19 and representation expenses of the Board of the  
20 Commission;

21 (2) not to exceed \$5,000 for official reception  
22 and representation expenses of the Secretary of the  
23 Commission; and

24 (3) not to exceed \$30,000 for official reception  
25 and representation expenses of the Administrator of  
26 the Commission.

1 (c) MOTOR VEHICLES.—Funds available to the Pan-  
2 ama Canal Commission shall be available for the purchase  
3 of not to exceed 43 passenger motor vehicles for replace-  
4 ment only (including large heavy-duty vehicles used to  
5 transport Commission personnel across the Isthmus of  
6 Panama), the purchase price of which shall not exceed  
7 \$19,500 per vehicle. These vehicles must be manufactured  
8 in the United States.

9 **SEC. 3. SCHOOL REIMBURSEMENT.**

10 Section 1321(e)(2) of the Panama Canal Act of 1979  
11 (22 U.S.C. 3731(e)(2)) is amended by inserting after  
12 “schools in the Republic of Panama” the following: “or  
13 in the United States”.

14 **SEC. 4. IMMIGRATION.**

15 Section 101(a)(27)(F) of the Immigration and Na-  
16 tionality Act (8 U.S.C. 1101(a)(27)(F)) is amended in  
17 clause (ii) by inserting after “subsequently” the following:  
18 “continues to be so employed or”.
