## A BILL

To extend caps on defense and nondefense discretionary spending through fiscal year 1998.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “National Security  
3 Budgeting and Deficit Control Act of 1994”.

4 **SEC. 2. EXTENSION OF SPENDING LIMITS.**

5 (a) CATEGORY.—Subparagraph (B) of section  
6 250(c)(4) of the Balanced Budget and Emergency Deficit  
7 Control Act of 1985 is amended to read as follows:

8 “(B) For fiscal years 1995 through 1998,  
9 any of the following subsets of discretionary ap-  
10 propriations: defense or nondefense. New ac-  
11 counts or activities shall be categorized in con-  
12 sultation with the Committees on Appropria-  
13 tions and the Budget of the House of Rep-  
14 resentatives and the Senate.”.

15 (b) DISCRETIONARY SPENDING.—Section 601(a)(2)  
16 of the Congressional Budget Act of 1974 is amended by  
17 striking subparagraphs (E) and (F) and inserting the fol-  
18 lowing:

19 “(E) with respect to fiscal year 1995—

20 “(i) for the defense category:  
21 \$265,316,000,000 in new budget authority  
22 and \$269,278,000,000 in outlays; and

23 “(ii) for the nondefense category:  
24 \$249,862,000,000 in new budget authority  
25 and \$270,358,000,000 in outlays;

26 “(F) with respect to fiscal year 1996—

1 “(i) for the defense category:  
2 \$257,760,000,000 in new budget authority  
3 and \$262,713,000,000 in outlays; and

4 “(ii) for the nondefense category:  
5 \$260,871,000,000 in new budget authority  
6 and \$284,605,000,000 in outlays;

7 “(G) with respect to fiscal year 1997—

8 “(i) for the defense category:  
9 \$257,974,000,000 in new budget authority  
10 and \$258,127,000,000 in outlays; and

11 “(ii) for the nondefense category:  
12 \$269,581,000,000 in new budget authority  
13 and \$288,752,000,000 in outlays; and

14 “(H) with respect to fiscal year 1998, for  
15 the discretionary category—

16 “(i) for the defense category:  
17 \$259,745,000,000 in new budget authority  
18 and \$256,569,000,000 in outlays; and

19 “(ii) for the nondefense category:  
20 \$270,347,000,000 in new budget authority  
21 and \$290,486,000,000 in outlays.”.

22 **SEC. 3. SPECIAL ALLOWANCES.**

23 (a) SPECIAL ALLOWANCE FOR DISCRETIONARY NEW  
24 BUDGET AUTHORITY.—Section 251(b)(2)(E) of the Bal-

1 anced Budget and Emergency Deficit Control Act of 1985  
2 is amended—

3 (1) in clause (iv), by inserting “for a category”  
4 after “new budget authority” the second place it ap-  
5 pears, and by inserting “for that category” before  
6 “for that fiscal year”; and

7 (2) by adding at the end the following new sen-  
8 tence: “The special budget authority adjustment re-  
9 quired in the final sequestration report for fiscal  
10 year 1995 required under section 253(g)(1)(B) and  
11 clause (ii) shall be equally divided between the de-  
12 fense and nondefense categories for each applicable  
13 fiscal year.”.

14 (b) SPECIAL OUTLAY ALLOWANCE.—Section  
15 251(b)(2)(F) of the Balanced Budget and Emergency  
16 Deficit Control Act of 1985 is amended—

17 (1) by striking “or 1995” and inserting “, and  
18 not to exceed \$3,250,000,000 in the defense cat-  
19 egory or \$3,250,000,000 in the nondefense category  
20 (as applicable) in fiscal year 1995”; and

21 (2) by inserting “for that category” before “in  
22 fiscal year 1996, 1997, or 1998”.

23 **SEC. 4. CONFORMING AMENDMENT.**

24 Section 250(c)(4) of the Balanced Budget and Emer-  
25 gency Deficit Control Act of 1985 is amended—

1           (1) in subparagraph (B) by striking “fiscal  
2           years 1994 and 1995” and inserting “fiscal year  
3           1994”; and

4           (2) by adding at the end the following new sub-  
5           paragraph:

6                   “(C) For fiscal years 1995, 1996, 1997,  
7                   and 1998, any of the following subsets of dis-  
8                   cretionary appropriations: defense or  
9                   nondefense.”.

○
