Mr. DE LA GARZA introduced the following bill; which was referred to the Committee on Public Works and Transportation

A BILL

To amend the Federal Water Pollution Control Act to authorize financial assistance for United States-Mexico wastewater treatment works.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Good Neighbor Water
5 Pollution Control Act of 1994”.

6 **SEC. 2. ASSISTANCE FOR UNITED STATES-MEXICO BORDER**
7 **WASTEWATER TREATMENT WORKS.**

8 Title V of the Federal Water Pollution Control Act
9 (33 U.S.C. 1251 et seq.) is amended by adding at the end
10 thereof the following new section:

1 **“SEC. 520. ASSISTANCE FOR UNITED STATES-MEXICO BOR-**
2 **DER WASTEWATER TREATMENT WORKS.**

3 “(a) PURPOSE.—The purpose of this section is to
4 protect the public health, environment, and quality of the
5 surface water and ground water of the United States-Mex-
6 ico border area from being polluted by raw or partially
7 treated sewage, in furtherance of the goals and objectives
8 of this Act and the November 1993 Agreement between
9 the Government of the United States of America and the
10 Government of the United Mexican States Concerning the
11 Establishment of a Border Environment Cooperation
12 Commission and the North American Development Bank.

13 “(b) EFFECT OF PROVISIONS.—This section shall not
14 be construed to affect or impair the provisions of any
15 agreement of the United States or any Federal legislation
16 applicable to the Border Environment Cooperation Com-
17 mission, the North American Development Bank, or the
18 International Boundary and Water Commission.

19 “(c) GENERAL AUTHORITY.—The Administrator may
20 provide financial and other assistance to the Border Envi-
21 ronment Cooperation Commission, any appropriate Fed-
22 eral, State, or local governmental entity, and the Inter-
23 national Boundary and Water Commission, subject to
24 such terms and conditions as the Administrator deems ap-
25 propriate, for the planning, design, and construction of
26 wastewater treatment works located in the United States-

1 Mexico border area, regardless of the place of origin or
2 ultimate destination of the wastewater. Assistance may be
3 provided under this section for wastewater treatment
4 works located near the United States-Mexico border area
5 if such treatment works would remedy a transboundary
6 environmental or health problem. All treatment works re-
7 ceiving assistance under this section shall be planned, de-
8 signed, and constructed in accordance with any applicable
9 agreement to which the United States is a party.

10 “(d) DEFINITION.—For the purposes of this section
11 the term ‘border area’ shall mean the area located within
12 100 kilometers of either side of the United States-Mexican
13 border.

14 “(e) AUTHORIZATION OF APPROPRIATIONS.—There
15 are authorized to be appropriated such sums as may be
16 necessary to carry out this section.”.
