A BILL

Entitled the “Anti-Hypocrisy Deficit Reduction Act”, to provide for anti-hypocritical adjustments for fiscal year 1994.

1 *Be it enacted by the Senate and House of Representa-*

3 **TITLE I—DISCRETIONARY CAP**

4 **ADJUSTMENTS**

5 **SECTION 101. DOWNWARD ADJUSTMENT OF DISCRE-**
6 **TIONARY SPENDING LIMITS.**

7 The discretionary spending limits (new budget au-
8 thority and outlays) for fiscal year 1994 set forth in sec-
9 tion 601(a)(2) of the Congressional Budget Act of 1974,

1 as adjusted in strict conformance with section 251 of the
2 Balanced Budget and Emergency Deficit Control Act of
3 1985, shall be reduced, as calculated by the Director of
4 the Office of Management and Budget, in amounts equal
5 to the aggregate amounts of rescissions under title II for
6 that fiscal year.

7 **SEC. 102. SPENDING LIMITS FOR FISCAL YEARS 1995-1998.**

8 (a) REDUCTION IN SPENDING LIMITS.—The discre-
9 tionary spending limits (new budget authority and out-
10 lays) for each of fiscal years 1995, 1996, 1997, and 1998
11 set forth in section 601(a)(2) of the Congressional Budget
12 Act of 1974, as adjusted in strict conformance with sec-
13 tion 251 of the Balanced Budget and Emergency Deficit
14 Control Act of 1985, shall be reduced, as calculated by
15 the Director of the Office of Management and Budget, by
16 the aggregate amounts of rescissions under title II for fis-
17 cal year 1994, plus any additional savings for that fiscal
18 year as a result of the enactment of title III.

19 (b) DEFINITION.—For purposes of subsection (a),
20 the term “additional savings for that fiscal year as a result
21 of the enactment of title III” means the net aggregate
22 amount (if any) by which fiscal year 1994 appropriations
23 (before any rescissions made under title II) for all pro-
24 grams, projects, and activities for which new authorization
25 levels are established by title III exceeds those new author-

1 ization levels for fiscal year 1995, 1996, 1997, or 1998,
2 as the case may be.
