5           ble fiscal year of whether the requirements under sub-  
6           section (a) are met; and

7           (2) notify the appropriate committees of the Con-  
8           gress on the first date of each quarter of each applica-  
9           ble fiscal year of the determinations made under  
10          paragraph (1).
