AN ACT

To amend the Consolidated Farm and Rural Development Act to make technical corrections to certain provisions relating to beginning farmers and ranchers.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Beginning Farmer
5 Technical Corrections Act of 1994”.

1 **SEC. 2. LAND OWNERSHIP LIMITATION MADE INAPPLICA-**
2 **BLE TO OPERATING LOANS.**

3 Section 343(a)(11) of the Consolidated Farm and
4 Rural Development Act (7 U.S.C. 1991(a)(11)) is amend-
5 ed by adding after and below the end the following:

6 “As used in subtitle B, the term ‘qualified beginning
7 farmer or rancher’ shall have the meaning given in
8 the preceding sentence without regard to subpara-
9 graph (F).”.

10 **SEC. 3. GRADUATION OF BORROWERS WITHOUT REGARD**
11 **TO YOUTH LOANS.**

12 Section 319 of the Consolidated Farm and Rural De-
13 velopment Act (7 U.S.C. 1949) is amended by adding at
14 the end the following:

15 “(c) DISREGARD OF LOANS MADE TO YOUTHS.—As
16 used in this section, the term ‘loan’ does not include any
17 loan made under section 311(b).”.

18 **SEC. 4. DIRECT LOAN HISTORY AND GUARANTEE HISTORY**
19 **TO BE CONSIDERED SEPARATELY IN APPLY-**
20 **ING THE TRANSITION RULE FOR GRADUA-**
21 **TION OF BORROWERS.**

22 Section 319(b)(2) of the Consolidated Farm and
23 Rural Development Act (7 U.S.C. 1949(b)(2)) is amended
24 to read as follows:

25 “(2) TRANSITION RULES.—

1 “(A) CONSIDERATION OF DIRECT LOAN
2 HISTORY.—If, as of October 28, 1992, the Sec-
3 retary has, for 5 or more years, made a direct
4 loan to a borrower under this subtitle, then,
5 after the 5th year (occurring after October 28,
6 1992) for which a direct loan has been made to
7 the borrower under this subtitle, the Secretary
8 shall not make a direct loan to the borrower
9 under this subtitle.

10 “(B) CONSIDERATION OF GUARANTEE HIS-
11 TORY.—If, as of October 28, 1992, the Sec-
12 retary has, for 10 or more years, provided a
13 guarantee under this subtitle with respect to a
14 loan made to a borrower, then, after the 5th
15 year (occurring after October 28, 1992) for
16 which a guarantee has been provided under this
17 subtitle with respect to a loan made to the bor-
18 rower, the Secretary shall not provide a guaran-
19 tee under this subtitle with respect to a loan
20 made to the borrower.”.
