A BILL

To require that, in the administration of any benefits program established by or under Federal law which requires the use of data obtained in the most recent decennial census, the 1990 adjusted census data be considered the official data for that decennial census.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REQUIREMENT THAT ADJUSTED DATA BE**
4 **USED.**

5 (a) DEFINITION.—For the purpose of this section,
6 the term “1990 adjusted census data” means data from
7 the 1990 decennial census of population, as adjusted by
8 the Bureau of the Census to take into account the findings
9 of the Selected Post-Enumeration Survey, dated June 13,
10 1991.

11 (b) REQUIREMENT.—For the purpose of section
12 141(e) of title 13, United States Code, the 1990 adjusted
13 census data shall be considered the most recent data avail-
14 able for the 1990 decennial census of population.

15 **SEC. 2. EFFECTIVE DATE.**

16 This Act shall take effect as of the first day of the
17 first fiscal year beginning on or after the date of the enact-
18 ment of this Act.
