H. R. 798

AMENDMENT

In the Senate of the United States,

July 28 (legislative day, June 30), 1993.

Resolved, That the bill from the House of Representatives (H.R. 798) entitled “An Act to amend title 38, United States Code, to codify the rates of disability compensation for veterans with service-connected disabilities and the rates of dependency and indemnity compensation for survivors of such veterans as such rates took effect on December 1, 1992”, do pass with the following

“²If the veteran served as Chairman or Vice-Chairman of the Joint Chiefs of Staff, Chief of Staff of the Army, Chief of Naval Operations, Chief of Staff of the Air Force, Commandant of the Marine Corps, or Commandant of the Coast Guard, at the applicable time designated by section 402 of this title, the surviving spouse’s rate shall be \$1,744.”;
