Mr. FROST, from the Committee on Rules, submitted the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 2348) making appropriations for the Legislative Branch for the fiscal year ending September 30, 1994, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of  
3 rule XXIII, declare the House resolved into the Committee  
4 of the Whole House on the State of the Union for consid-  
5 eration of the bill (H.R. 2348) making appropriations for  
6 the Legislative Branch for the fiscal year ending Septem-  
7 ber 30, 1994, and for other purposes. The first reading

1 of the bill shall be dispensed with. All points of order  
2 against consideration of the bill are waived. General de-  
3 bate shall be confined to the bill and shall not exceed one  
4 hour equally divided and controlled by the chairman and  
5 ranking minority member of the Committee on Appropria-  
6 tions. After general debate the bill shall be considered for  
7 amendment under the five-minute rule and shall be consid-  
8 ered as read. Points of order under clause 2 or 6 of rule  
9 XXI against provisions in the bill are waived except as  
10 follows: beginning on page 31, line 20, through page 32,  
11 line 2. No amendment shall be in order except those print-  
12 ed in the report of the Committee on Rules accompanying  
13 this resolution. Each amendment may be offered only in  
14 the order printed, may be offered only by the named pro-  
15 ponent or a designee, shall be considered as read, shall  
16 be debatable for the time specified in the report equally  
17 divided and controlled by the proponent and an opponent,  
18 shall not be subject to amendment, and shall not be sub-  
19 ject to a demand for division of the question in the House  
20 or in the Committee of the Whole. Points of order under  
21 clause 2 of rule XXI against amendments printed in the  
22 report are waived. At the conclusion of consideration of  
23 the bill for amendment the Committee shall rise and re-  
24 port the bill to the House with such amendments as may  
25 have been adopted. The previous question shall be consid-

1 ered as ordered on the bill and amendments thereto to  
2 final passage without intervening motion except one mo-  
3 tion to recommit.
