Mr. MOAKLEY, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 5) to amend the National Labor Relations Act and the Railway Labor Act to prevent discrimination based on participation in labor disputes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 5) to amend the National Labor
6 Relations Act and the Railway Labor Act to prevent dis-

1 crimination based on participation in labor disputes. The
2 first reading of the bill shall be dispensed with. General
3 debate shall be confined to the bill and to the amendments
4 made in order by this resolution and shall not exceed two
5 hours, with 60 minutes equally divided and controlled by
6 the chairman and ranking minority member of the Com-
7 mittee on Education and Labor, 30 minutes equally di-
8 vided and controlled by the chairman and ranking minor-
9 ity member of the Committee on Energy and Commerce,
10 and 30 minutes equally divided and controlled by the
11 chairman and ranking minority member of the Committee
12 on Public Works and Transportation. After general debate
13 the bill shall be considered for amendment under the five-
14 minute rule and shall be considered as read. The amend-
15 ments recommended by the Committee on Education and
16 Labor now printed in the bill shall be considered as adopt-
17 ed in the House and in the Committee of the Whole. No
18 further amendment shall be in order except those printed
19 in the report of the Committee on Rules accompanying
20 this resolution. Each amendment may be offered only in
21 the order printed, may be offered only by the named pro-
22 ponent or a designee, shall be considered as read, shall
23 be debatable for the time specified in the report equally
24 divided and controlled by the proponent and an opponent,
25 and shall not be subject to amendment. Points of order

1 against the amendment printed in the report to be offered
2 by Representative Ridge of Pennsylvania for failure to
3 comply with clause 7 of rule XVI are waived. At the con-
4 clusion of consideration of the bill for amendment the
5 Committee shall rise and report the bill to the House with
6 such amendments as may have been adopted. The previous
7 question shall be considered as ordered on the bill and
8 amendments thereto to final passage without intervening
9 motion except one motion to recommit with or without in-
10 structions.
