Mr. BEILENSON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2351) to authorize appropriations for fiscal years 1994 and 1995 to carry out the National Foundation on the Arts and the Humanities Act of 1965, and the Museum Services Act.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 2351) to authorize appropriations

1 for fiscal years 1994 and 1995 to carry out the National
2 Foundation on the Arts and the Humanities Act of 1965,
3 and the Museum Services Act. The first reading of the
4 bill shall be dispensed with. General debate shall be con-
5 fined to the bill and shall not exceed one hour equally di-
6 vided and controlled by the chairman and ranking minor-
7 ity member of the Committee on Education and Labor.
8 After general debate the bill shall be considered for
9 amendment under the five-minute rule. The bill shall be
10 considered as read. No amendment to the bill shall be in
11 order except those printed in the report of the Committee
12 on Rules accompanying this resolution. Each amendment
13 may be offered only in the order printed in the report,
14 may be offered only by a Member designated in the report,
15 shall be considered as read, shall be debatable for the time
16 specified in the report equally divided and controlled by
17 the proponent and an opponent, shall not be subject to
18 amendment, and shall not be subject to a demand for divi-
19 sion of the question in the House or in the Committee
20 of the Whole. Points of order against the amendments
21 printed in the report for failure to comply with clause 7
22 of rule XVI are waived. At the conclusion of consideration
23 of the bill for amendment the Committee shall rise and
24 report the bill to the House with such amendments as may
25 have been adopted. The previous question shall be consid-

1 ered as ordered on the bill and amendments thereto to
2 final passage without intervening motion except one mo-
3 tion to recommit.
