## RESOLUTION

Providing for consideration of the concurrent resolution (H. Con. Res. 170) directing the President pursuant to section 5(c) of the War Powers Resolution to remove United States Armed Forces from Somalia by January 31, 1994.

1       *Resolved*, That upon the adoption of this resolution  
2 it shall be in order to consider in the House the concurrent  
3 resolution (H. Con. Res. 170) directing the President pur-  
4 suant to section 5(c) of the War Powers Resolution to re-  
5 move United States Armed Forces from Somalia by Janu-

1 ary 31, 1994. The amendment in the nature of a sub-  
2 stitute recommended by the Committee on Foreign Affairs  
3 now printed in the concurrent resolution shall be consid-  
4 ered as adopted. The previous question shall be considered  
5 as ordered on the concurrent resolution, as so amended,  
6 to final adoption without intervening motion except: (1)  
7 the further amendment in the nature of a substitute print-  
8 ed in part 1 of the report of the Committee on Rules ac-  
9 companying this resolution; (2) the further amendment in  
10 the nature of a substitute printed in part 2 of the report  
11 of the Committee on Rules accompanying this resolution;  
12 and (3) one motion to recommit. Each of the amendments  
13 printed in the report of the Committee on Rules may be  
14 offered only in the order printed in the report, may be  
15 offered only by a Member designated in the report, shall  
16 be considered as read, and shall be debatable for the time  
17 specified in the report equally divided and controlled by  
18 the proponent and an opponent. All points of order against  
19 the amendments printed in the report are waived. If more  
20 than one of the amendments printed in the report is  
21 adopted, only the last to be adopted shall be considered  
22 as finally adopted.

23       SEC. 2. The provisions of section 7 of the War Powers  
24 Resolution (50 U.S.C. 1546) shall not apply during the  
25 remainder of the first session of the One Hundred Third

1 Congress to a concurrent resolution introduced pursuant  
2 to section 5 of the War Powers Resolution (50 U.S.C.  
3 1544) with respect to Somalia.
