# RESOLUTION

To establish the Select Committee on Aging.

1     *Resolved,*

2     **SECTION 1. ESTABLISHMENT OF SELECT COMMITTEE ON**  
3                   **AGING.**

4           There is hereby established in the House of Rep-  
5     resentatives a select committee to be known as the Select  
6     Committee on Aging (hereinafter in this resolution re-  
7     ferred to as the “select committee”).

8     **SEC. 2. FUNCTIONS.**

9           The select committee shall not have legislative juris-  
10    diction. The select committee shall have authority—

11           (1) to conduct a continuing comprehensive  
12    study and review of the problems of the older Amer-  
13    ican, including but not limited to income mainte-  
14    nance, housing, health (including medical research),  
15    welfare, employment, education, recreation, and par-  
16    ticipation in family and community life as self-re-  
17    specting citizens;

18           (2) to study the use of all practicable means  
19    and methods of encouraging the development of pub-  
20    lic and private programs and policies which will as-

1       sist the older American in taking a full part in na-  
2       tional life and which will encourage the utilization of  
3       the knowledge, skills, special aptitudes, and abilities  
4       of older Americans to contribute to a better quality  
5       of life for all Americans;

6               (3) to develop policies that would encourage the  
7       coordination of both governmental and private pro-  
8       grams designed to deal with problems of aging; and

9               (4) to review any recommendations made by the  
10      President or by the White House Conference on  
11      Aging relating to programs or policies affecting older  
12      Americans.

13   **SEC. 3. APPOINTMENT AND MEMBERSHIP.**

14      (a) The select committee shall be composed of *not*  
15      *more than* 67 Members, who shall be appointed by the  
16      Speaker, one of whom he shall designate as chairman.

17      (b) Any vacancy occurring in the membership of the  
18      select committee shall be filled in the same manner in  
19      which the original appointment was made.

20      (c) For purposes of this section, the term "Members"  
21      shall include any Representative in, or Delegate or Resi-  
22      dent Commissioner to, the House of Representatives.

23   **SEC. 4. AUTHORITY AND PROCEDURES.**

24      (a) For the purpose of carrying out this resolution,  
25      the select committee is authorized to sit and act during

1 the present Congress at such times and places within the  
2 United States, including any Commonwealth or possession  
3 thereof, or elsewhere, whether the House is in session, has  
4 recessed, or has adjourned, and to hold such hearings as  
5 it deems necessary.

6 (b) The provisions of clauses 1, 2, and 3 of rule XI  
7 of the Rules of the House of Representatives shall apply  
8 to the select committee.

9 **SEC. 5. ADMINISTRATIVE PROVISIONS.**

10 (a) Subject to the adoption of expense resolutions as  
11 required by clause 5 of rule XI of the Rules of the House  
12 of Representatives, the select committee may incur ex-  
13 penses in connection with its duties under this resolution.

14 (b) In carrying out its functions under this resolution,  
15 the select committee is authorized—

16 (1) to appoint, either on a permanent basis or  
17 as experts or consultants, such staff as the select  
18 committee considers necessary;

19 (2) to prescribe the duties and responsibilities  
20 of such staff;

21 (3) to fix the compensation of such staff at a  
22 single per annum gross rate as provided by clause  
23 6(c) of rule XI of the Rules of the House of Rep-  
24 resentatives;

1           (4) to terminate the employment of any such  
2 staff as the select committee considers appropriate;  
3 and

4           (5) to reimburse members of the select commit-  
5 tee and of its staff for travel, subsistence, and other  
6 necessary expenses incurred by them in the perform-  
7 ance of their duties and responsibilities for the select  
8 committee, other than expenses in connection with  
9 any meeting of the select committee held in the Dis-  
10 trict of Columbia.

11 **SEC. 6. REPORTS.**

12           (a)(1) The select committee shall report to the House  
13 with respect to the results of any investigation or study  
14 it conducts.

15           (2) The select committee shall submit an annual re-  
16 port to the House which shall include a summary of the  
17 activities of the select committee during the calendar year  
18 to which the report applies.

19           (b) Any such report which is made when the House  
20 is not in session shall be filed with the Clerk of the House.
