Mr. SHAW (for himself, Mr. MICHEL, Mr. GINGRICH, Mr. SANTORUM, Mr. DELAY, Mr. GRANDY, Mr. CAMP, Mrs. JOHNSON of Connecticut, and Mr. CASTLE) submitted the following resolution; which was referred to the Committee on Rules

RESOLUTION

Providing for the consideration of the bill (H.R. 3500) to amend title IV of the Social Security Act to provide welfare families with the education, training, job search, and work experience needed to prepare them to leave welfare within two years, to increase the rate of paternity establishment for children receiving welfare benefits, to provide States with greater flexibility in providing welfare, to authorize States to conduct demonstration projects to test the effectiveness of policies designed to

help people leave welfare and increase their financial security, to strengthen child support enforcement, and to eliminate welfare payments for most groups of noncitizens.

1 *Resolved*, That immediately upon the adoption of this
2 resolution the House shall resolve itself into the Commit-
3 tee of the Whole House on the state of the Union for the
4 consideration of the bill (H.R. 3500) to amend title IV
5 of the Social Security Act to provide welfare families with
6 the education, training, job search, and work experience
7 needed to prepare them to leave welfare within two years,
8 to increase the rate of paternity establishment for children
9 receiving welfare benefits, to provide States with greater
10 flexibility in providing welfare, to authorize States to con-
11 duct demonstration projects to test the effectiveness of
12 policies designed to help people leave welfare and increase
13 their financial security, to strengthen child support en-
14 forcement, and to eliminate welfare payments for most
15 groups of noncitizens. The first reading of the bill shall
16 be dispensed with, and all points of order against the bill
17 and against its consideration are waived. After general de-
18 bate which shall be confined to the bill, and which shall
19 not exceed six hours, four hours to be equally divided and
20 controlled by the chairman and ranking minority member
21 of the Committee on Ways and Means, and two hours to
22 be equally divided and controlled by the chairman and

1 ranking minority member of the Committee on Education
2 and Labor, the bill shall be considered for amendment
3 under the five-minute rule, and each section shall be con-
4 sidered as read.

5 If on any day the Committee of the Whole rises and
6 reports that it has come to no resolution on the bill, then
7 on the next legislative day the House shall, immediately
8 after the approval of the Journal, resolve into the Commit-
9 tee of the Whole for further consideration of the bill.

10 At the conclusion of the consideration of the bill for
11 amendment the Committee shall rise and report the bill
12 to the House with such amendment as may have been
13 adopted. The previous question shall be considered as or-
14 dered on the bill and any amendment thereto to final pas-
15 sage without intervening motion except one motion to re-
16 commit, with or without instructions.
