Mr. HALL of Ohio, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for further
5 consideration of the joint resolution (H.J. Res. 416) pro-
6 viding limited authorization for the participation of United
7 States Armed Forces in the multinational force in Haiti
8 and providing for the prompt withdrawal of United States

1 Armed Forces from Haiti. All time for general debate
2 under the terms of any previous order of the House shall
3 be considered as expired. After further general debate,
4 which shall be confined to the joint resolution and the
5 amendments made in order by this resolution and shall
6 not exceed two hours equally divided and controlled by the
7 chairman and ranking minority member of the Committee
8 on Foreign Affairs, the joint resolution shall be considered
9 for amendment under the five-minute rule and shall be
10 considered as read. The amendments printed in part 1 of
11 the report of the Committee on Rules accompanying this
12 resolution shall be considered as adopted in the House and
13 the Committee of the Whole. No further amendment shall
14 be in order in the House or in the Committee of the Whole
15 except those printed in part 2 of the report of the Commit-
16 tee on Rules. Each further amendment may be offered
17 only in the order printed in the report, may be offered
18 only by a Member designated in the report, shall be con-
19 sidered as read, shall be debatable for the time specified
20 in the report equally divided and controlled by the pro-
21 ponent and an opponent, and shall not be subject to
22 amendment except as specified in the report. All points
23 of order against the amendments printed in the report are
24 waived. If more than one of the amendments printed in
25 part 2 of the report is adopted, only the last to be adopted

1 shall be considered as finally adopted and reported to the
2 House. At the conclusion of consideration of the joint reso-
3 lution for amendment the Committee shall rise and report
4 the joint resolution to the House with such amendment
5 as may have been finally adopted. The previous question
6 shall be considered as ordered on the joint resolution and
7 any amendment thereto to final passage without interven-
8 ing motion except one motion to recommit with or without
9 instructions.
