RESOLUTION

Providing for the consideration of the bill (H.R. 670) to require the Secretary of Health and Human Services to ensure that pregnant women receiving assistance under title X of the Public Health Service Act are provided with information and counseling regarding their pregnancies, and for other purposes.

- 1 *Resolved*, That at any time after the adoption of this
- 2 resolution the Speaker may, pursuant to clause 1(b) of
- 3 rule XXIII, declare the House resolved into the Committee

1 of the Whole House on the state of the Union for consider-
2 ation of the bill (H.R. 670) to require the Secretary of
3 Health and Human Services to ensure that pregnant
4 women receiving assistance under title X of the Public
5 Health Service Act are provided with information and
6 counseling regarding their pregnancies, and for other pur-
7 poses. The first reading of the bill shall be dispensed with.
8 All points of order against consideration of the bill for fail-
9 ure to comply with clause 2(l)(6) of rule XI are waived.
10 General debate shall be confined to the bill and shall not
11 exceed one hour equally divided and controlled by the
12 chairman and ranking minority member of the Committee
13 on Energy and Commerce. After general debate the bill
14 shall be considered for amendment under the five-minute
15 rule and shall be considered as read. No amendment shall
16 be in order except the amendment printed in the report
17 of the Committee on Rules accompanying this resolution,
18 which may be offered only by the named proponent or a
19 designee, shall be considered as read, shall be debatable
20 for the time specified in the report equally divided and
21 controlled by the proponent and an opponent, shall not
22 be subject to amendment, and shall not be subject to a
23 demand for division of the question in the House or in
24 the Committee of the Whole. At the conclusion of consider-
25 ation of the bill for amendment the Committee shall rise

1 and report the bill to the House with such amendment
2 as may have been adopted. The previous question shall
3 be considered as ordered on the bill and amendment there-
4 to to final passage without intervening motion except one
5 motion to recommit.
