A BILL

To prohibit the importation of semiautomatic assault weapons, large capacity ammunition feeding devices, and certain accessories.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PROHIBITION ON IMPORTATION OF SEMIAUTO-**
4 **MATIC ASSAULT RIFLES AND ASSAULT PIS-**
5 **TOLS.**

6 (a) GENERAL RULE.—Except as provided in sub-
7 section (b), the importation into the United States of the
8 following articles is prohibited:

- 9 (1) Semiautomatic assault rifle.
10 (2) Semiautomatic assault pistol.

1 (3) Large capacity ammunition feeding device.

2 (4) Semiautomatic assault weapon accessory.

3 (b) EXCEPTION.—Subsection (a) does not apply to
4 the importation of an article under the authority of the
5 United States, by a department or agency of the United
6 States, or by a department or agency of a State or political
7 subdivision of a State.

8 **SEC. 2. DEFINITIONS.**

9 For the purposes of this Act:

10 (1) SEMIAUTOMATIC ASSAULT RIFLE.—The
11 term “semiautomatic assault rifle” means a rifle of

1 (2) SEMIAUTOMATIC ASSAULT PISTOL.—The
 2 term “semiautomatic assault pistol” means a pistol
 3 of one of the following types:

Uzi type
 Heckler & Koch SP-89 type
 Australian Automatic Arms SAP type
 Spectre Auto type
 Sterling Mark 7 type
 Any other type determined by the President to be appropriate

4 (3) LARGE-CAPACITY AMMUNITION FEEDING
 5 DEVICE.—The term “large-capacity ammunition
 6 feeding device” means a detachable magazine, belt,
 7 drum, feed strip, or similar device that has a capac-
 8 ity of, or that can be readily restored or converted
 9 to accept, more than 5 rounds of ammunition, in-
 10 cluding a combination of parts from which such a
 11 device can be assembled, but not including an at-
 12 tached tubular device designed to accept and capable
 13 of operating with only .22 rimfire caliber ammuni-
 14 tion.

15 (4) SEMIAUTOMATIC ASSAULT WEAPON ACCES-
 16 SORY.—The term “semiautomatic assault weapon
 17 accessory” means 1 of the following articles if the
 18 article is specifically designed for use with a semi-
 19 automatic weapon:

Grenade launcher
 Bayonet
 Flash suppressor
 Night sight
 Adaptor designed to facilitate the attachment of a silencer or
 flash suppressor

A combination of parts from which one of the foregoing articles
can be assembled

A part designed solely for use in assembling one of the foregoing
articles

Any other article determined by the President to be appropriate
