Mr. GLENN introduced the following bill; which was read twice and referred to the Committee on Environment and Public Works

A BILL

To provide for a pollution prevention for cities program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. POLLUTION PREVENTION FOR CITIES PRO-**

4 **GRAM.**

5 (a) IN GENERAL.—Section 118 of the Federal Water
6 Pollution Control Act (33 U.S.C. 1268) is amended—

7 (1) by redesignating subsections (g) and (h) as
8 subsections (i) and (j), respectively; and

9 (2) by inserting after subsection (f) the follow-
10 ing new subsection:

1 “(g) POLLUTION PREVENTION FOR CITIES PRO-
2 GRAM.—

3 “(1) APPLICATION FOR TECHNICAL ASSIST-
4 ANCE.—A municipality located within the Great
5 Lakes basin boundaries may apply for technical and
6 financial assistance from the Administrator to imple-
7 ment source reduction of toxic pollutants in urban
8 runoff, wastewater, and stormwater.

9 “(2) ELIGIBILITY.—To be eligible for assistance
10 under this subsection, a municipality shall apply to
11 the Administrator with a statement—

12 “(A) stating pollutant reduction goals; and

13 “(B) documenting stakeholder interest in
14 implementing voluntary pollutant reduction
15 measures.

16 “(3) ASSISTANCE.—The Administrator shall,
17 for each municipality with an approved application
18 statement—

19 “(A) provide technical assistance in the de-
20 velopment of a municipal source reduction ac-
21 tion plan; and

22 “(B) authorize the expenditure of State re-
23 volving fund monies pursuant to section 602(a)
24 for the implementation of an approved source
25 reduction plan.”.

1 (b) CONFORMING AMENDMENTS.—

2 (1) REVOLVING FUNDS.—Section 601(a) of the
3 Federal Water Pollution Control Act (33 U.S.C.
4 1381(a)) is amended—

5 (A) by striking “and” at the end of para-
6 graph (2); and

7 (B) by inserting before the period at the
8 end the following: “, and (4) for implementing
9 a source reduction action plan that has been
10 approved by the Administrator pursuant to sec-
11 tion 118(g)”.

12 (2) PROJECTS ELIGIBLE FOR ASSISTANCE.—
13 The first sentence of section 603(c) of such Act (33
14 U.S.C. 1383(c)) is amended—

15 (A) by striking “and” at the end of para-
16 graph (2); and

17 (B) by inserting before the period at the
18 end the following: “, and (4) for implementing
19 a source reduction action plan that has been
20 approved by the Administrator pursuant to sec-
21 tion 118(g)”.
