A BILL

To extend the suspension of duties on certain chemicals.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SUSPENSION OF DUTIES ON CERTAIN CHEMI-**
4 **CALS.**

5 Subchapter II of chapter 99 of the Harmonized Tar-

16 **SEC. 2. EFFECTIVE DATE.**

17 (a) IN GENERAL.—The amendments made by section
18 1 shall apply with respect to goods entered, or withdrawn
19 from warehouse for consumption, on or after the 15th day
20 after the date of the enactment of this Act.

21 (b) RETROACTIVE PROVISION.—Notwithstanding sec-
22 tion 514 of the Tariff Act of 1930 or any other provision
23 of law, upon a request filed with the appropriate customs
24 officer on or before the 90th day after the date of the
25 enactment of this Act, any entry, or withdrawal from

1 warehouse for consumption, of an article to which an
2 amendment made by section 1 applies—

3 (1) that was made after December 31, 1992,
4 and before the 15th day after the date of the enact-
5 ment of this Act; and

6 (2) and with respect to which there would have
7 been a lower duty if an amendment made by section
8 1 applied to such entry or withdrawal,
9 shall be liquidated or reliquidated as though such entry
10 or withdrawal had occurred on such 15th day.
