1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Stewart B. McKinney
5 Homeless Assistance Reauthorization Act of 1993”.

1 **SEC. 2. PRIMARY HEALTH SERVICES FOR HOMELESS CHIL-**
2 **DREN.**

3 Section 340(s)(8) of the Public Health Service Act
4 (42 U.S.C. 256(s)(8)) is amended by striking “1993” and
5 inserting “1994”.

6 **SEC. 3. COMMUNITY DEMONSTRATION PROJECTS.**

7 Section 612(a) of the Stewart B. McKinney Homeless
8 Assistance Act (42 U.S.C. 290aa-3 note) is amended by
9 striking “1993” and inserting “1994”.

10 **SEC. 4. ADULT EDUCATION ASSISTANCE TO HOMELESS**
11 **PERSONS.**

12 Section 702(c)(1) of the Stewart B. McKinney Home-
13 less Assistance Act (42 U.S.C. 11421(c)(1)) is amended
14 by striking “and 1993” and inserting “through 1994”.

15 **SEC. 5. EDUCATION FOR HOMELESS CHILDREN AND**
16 **YOUTH.**

17 (a) **AUTHORIZATION OF APPROPRIATIONS.**—Section
18 722(g)(1) of the Stewart B. McKinney Homeless Assist-
19 ance Act (42 U.S.C. 11432(g)(1)) is amended by striking
20 “and 1993” and inserting “through 1994”.

21 (b) **LOCAL EDUCATIONAL AGENCY GRANTS.**—Sec-
22 tion 723(b) of such Act (42 U.S.C. 11433(b)) is amend-
23 ed—

24 (1) by inserting after the subsection heading
25 the following: “Authorized activities may include—”;

26 (2) by striking paragraph (1);

1 (3) in paragraph (2)—

2 (A) by striking “(2)” and all that follows
3 in the matter preceding subparagraph (A);

4 (B) by redesignating subparagraphs (A)
5 through (O) as paragraphs (2) through (16),
6 respectively; and

7 (C) by inserting before paragraph (2) (as
8 redesignated by subparagraph (B)) the follow-
9 ing new paragraph:

10 “(1) the provision of tutoring, remedial edu-
11 cation services, or other education services to home-
12 less children or homeless youths;”; and

13 (4) by realigning the margins of paragraphs (1)
14 through (15) (as redesignated by paragraph (3)(B))
15 so as to align with paragraph (3) of subsection (a).

16 **SEC. 6. JOB TRAINING FOR THE HOMELESS.**

17 (a) REPORT.—Section 736(a) of the Stewart B.
18 McKinney Homeless Assistance Act (42 U.S.C. 11446(a))
19 is amended by striking “the termination date specified in
20 section 741” and inserting “the end of the last fiscal year
21 specified in section 739(a)”.

22 (b) AUTHORIZATION OF APPROPRIATIONS.—Section
23 739(a) of such Act (42 U.S.C. 11449(a)) is amended by
24 inserting after paragraph (3), the following new para-
25 graph:
