AN ACT

To amend title V of Public Law 96–550, designating the Chaco Culture Archeological Protection Sites, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Chacoan Outliers Pro-
5 tection Act of 1993”.

1 **SEC. 2. CONFORMING AMENDMENT.**

2 (a) Section 501 of Public Law 96–550 (16 U.S.C.
3 410ii) is amended in the title by striking “Congressional
4 findings” and inserting in lieu thereof “Congressional
5 findings and purpose”.

6 (b) Section 501(b) of Public Law 96–550 (16 U.S.C.
7 410ii(b)) is amended by striking “San Juan Basin;” and
8 inserting in lieu thereof, “San Juan Basin and surround-
9 ing areas;”.

10 **SEC. 3. ADDITIONS TO CHACO ARCHEOLOGICAL PROTEC-**
11 **TION SITES.**

12 Subsection 502(b) of Public Law 96–550 (16 U.S.C.
13 410ii–1(b)) is amended to read as follows:

14 “(b)(1) Thirty-nine outlying sites as generally de-
15 picted on a map entitled “Chaco Culture Archeological
16 Protection Sites”, numbered 310/80,033–B and dated
17 September 1991, are hereby designated as ‘Chaco Culture
18 Archeological Protection Sites’. The thirty-nine archeologi-
19 cal protection sites totaling approximately 14,372 acres
20 identified as follows:

1 “(2) The map referred to in paragraph (1) shall be
2 kept on file and available for public inspection in the ap-
3 propriate offices of the National Park Service, the office
4 of the State Director of the Bureau of Land Management
5 located in Santa Fe, New Mexico, the office of the Area
6 Director of the Bureau of Indian Affairs located in Win-
7 dow Rock, Arizona, and the offices of the Arizona and
8 New Mexico State Historic Preservation Officers.”.

9 **SEC. 4. ASSISTANCE TO THE NAVAJO NATION.**

10 Section 506 of Public Law 96–550 (16 U.S.C. 410ii–
11 5) is amended by adding the following new subsection at
12 the end thereof:

1 “(f) The Secretary is authorized to assist the Navajo
2 Nation in the protection and management of those Chaco
3 Culture Archeological Protection Sites located on lands
4 under the jurisdiction of the Navajo Nation through a
5 grant, contract, or cooperative agreement entered into
6 pursuant to the Indian Self-Determination and Education
7 Act (Public Law 93–638), as amended, to assist the Nav-
8 ajo Nation in site planning, resource protection, interpre-
9 tation, resource management actions, and such other pur-
10 poses as may be identified in such grant, contract, or coop-
11 erative agreement.”.
