AN ACT

To provide for the rehabilitation of historic structures within the Sandy Hook Unit of Gateway National Recreation Area in the State of New Jersey, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. MARINE ACADEMY AGREEMENT.**

2 (a) IN GENERAL.—In order to further the revitaliza-
3 tion, rehabilitation, and utilization of Fort Hancock within
4 the Sandy Hook Unit of Gateway National Recreation
5 Area, the Secretary of the Interior may enter into an
6 agreement with the Monmouth County Vocational School
7 District or a successor (referred to in this Act as the “Dis-
8 trict”), to permit the use by the District of properties situ-
9 ated along Gunnison Road and Magruder Road for the
10 purpose of developing and operating, without cost to the
11 National Park Service, a secondary school program to be
12 known as the Marine Academy of Science and Technology.

13 (b) DESIGN OF FACILITIES.—The design of new fa-
14 cilities and landscape improvements, and the rehabilitation
15 of existing facilities for school and administrative use,
16 shall be subject to the approval of the Director of the Na-
17 tional Park Service. In determining whether to approve
18 the design and rehabilitation, the Director shall use stand-
19 ards for rehabilitation and National Park Service guide-
20 lines and policies that are approved by the Secretary of
21 the Interior.

22 **SEC. 2. REVERSION.**

23 If the properties, facilities, and improvements re-
24 ferred to in section 1 are not used by the District for a
25 secondary school program, the agreement authorized by
26 section 1 shall be terminated and all use of the properties,

1 facilities, and improvements shall revert, without consider-
2 ation, to the National Park Service.

3 **SEC. 3. REIMBURSEMENT.**

4 (a) REHABILITATION.—As a condition of entering
5 into the agreement authorized by section 1, the Secretary
6 of the Interior may—

7 (1) accept reimbursement expenses, of not more
8 than \$500,000, to cover the cost of rehabilitating
9 other property within the Sandy Hook Unit of Gate-
10 way National Recreation Area for park uses that are
11 displaced from facilities used by the District under
12 the agreement authorized by section 1; or

13 (2) require the District to rehabilitate other
14 property for the park uses—

15 (A) under the direction of the National
16 Park Service; and

17 (B) at a cost of not more than \$500,000.

18 (b) FEES FOR SERVICES.—The Director of the Na-
19 tional Park Service may collect and retain reasonable fees
20 for services provided to the District by the National Park

- 1 Service, including alarm monitoring, permit compliance,
- 2 fire and police protection, and snow removal.
