Mr. KOHL introduced the following bill; which was read twice and referred to the Committee on Finance

A BILL

To amend the Harmonized Tariff Schedule of the United States to correct the rate of duty on certain agglomerated cork products.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. AGGLOMERATED CORK PRODUCTS.**

4 (a) IN GENERAL.—The article description for sub-
5 heading 4504.10.10 of the Harmonized Tariff Schedule of
6 the United States is amended to read as follows:

7 “Vulcanized blocks, plates, cylinders, sheets, slabs
8 and other shapes wholly of ground or pulverized
9 cork”.

1 (b) CUT OR MOLDED AGGLOMERATED CORK.—Chap-
 2 ter 45 of the Harmonized Tariff Schedule of the United
 3 States is amended by inserting in numerical sequence the
 4 following new subheading with the article description hav-
 5 ing the same degree of indentation as the article descrip-
 6 tion in subheading 4504.90.20:

“	4504.90.10	Agglomerated cork, not further advanced than cut or molded into blocks, plates, cylinders, sheets, slabs, rods, sticks, strips and other shapes	5.5¢/kg	Free (A, CA, E, IL)	22¢/kg	”.

7 **SEC. 2. EFFECTIVE DATE.**

8 (a) IN GENERAL.—The amendments made by section
 9 1 apply with respect to goods entered, or withdrawn from
 10 warehouse for consumption, on or after the 15th day after
 11 the date of the enactment of this Act.

12 (b) RELIQUIDATION.—Notwithstanding section 514
 13 of the Tariff Act of 1930 (19 U.S.C. 1514) or any other
 14 provision of law, upon a request filed with the appropriate
 15 customs officer before the date which is 90 days after the
 16 date of the enactment of this Act, any entry of an article
 17 described in heading 4504 of the Harmonized Tariff
 18 Schedule of the United States (as amended by section 1)
 19 that was made—

20 (1) after December 31, 1988, and

21 (2) before the 15th day after the date of the en-
 22 actment of this Act,

1 and with respect to which there would have been a lesser
2 duty if the amendments made by section 1 applied to such
3 entry, shall be liquidated or reliquidated as though such
4 amendments applied to such entry.
