Authorizing expenditures by the Committee on the Budget.

IN THE SENATE OF THE UNITED STATES

FEBRUARY 2 (legislative day, JANUARY 5), 1993

Mr. SASSER, from the Committee on the Budget, reported the following original resolution, which was referred to the Committee on Rules and Administration

RESOLUTION

Authorizing expenditures by the Committee on the Budget.

1 *Resolved*, That, in carrying out its powers, duties, and
2 functions under the Standing Rules of the Senate, in ac-
3 cordance with its jurisdiction under rule XXV of such
4 rules, including holding hearings, reporting such hearings,
5 and making investigations as authorized by paragraphs 1
6 and 8 of rule XXVI of the Standing Rules of the Senate,
7 the Committee on the Budget is authorized from March
8 1, 1993, through February 28, 1994, and March 1, 1994,
9 through February 28, 1995, in its discretion—

10 (1) to make expenditures from the contingent
11 fund of the Senate,

1 (2) to employ personnel, and

2 (3) with the prior consent of the Government
3 department or agency concerned and the Committee
4 on Rules and Administration, to use on a reimburs-
5 able or nonreimbursable basis the services of person-
6 nel of any such department or agency.

7 SEC. 2. (a) The expenses of the committee for the
8 period March 1, 1993, through February 28, 1994, under
9 this resolution shall not exceed \$3,424,833, of which
10 amount—

11 (1) not to exceed \$20,000 may be expended for
12 the procurement of the services of individual consult-
13 ants, or organizations thereof (as authorized by sec-
14 tion 202(i) of the Legislative Reorganization Act of
15 1946, as amended), and

16 (2) not to exceed \$2,000 may be expended for
17 the training of the professional staff of such commit-
18 tee (under procedures specified by section 202(j) of
19 the Legislative Reorganization Act of 1946).

20 (b) For the period March 1, 1994, through February
21 28, 1995, expenses of the committee under this resolution
22 shall not exceed \$3,499,838, of which amount—

23 (1) not to exceed \$20,000 may be expended for
24 the procurement of the services of individual consult-
25 ants, or organizations thereof (as authorized by sec-

1 tion 202(i) of the Legislative Reorganization Act of
2 1946, as amended), and

3 (2) not to exceed \$2,000 may be expended for
4 the training of the professional staff of such commit-
5 tee (under procedures specified by section 202(j) of
6 the Legislative Reorganization Act of 1946).

7 SEC. 3. The committee shall report its findings, to-
8 gether with such recommendations for legislation as it
9 deems advisable, to the Senate at the earliest practicable
10 date, but not later than February 28, 1994, and February
11 28, 1995, respectively.

12 SEC. 4. Expenses of the committee under this resolu-
13 tion shall be paid from the contingent fund of the Senate
14 upon vouchers approved by the chairman of the commit-
15 tee, except that vouchers shall not be required for—

16 (1) the disbursement of salaries of employees
17 paid at an annual rate,

18 (2) the payment of telecommunications provided
19 by the Office of the Sergeant at Arms and Door-
20 keeper, United States Senate,

21 (3) the payment of stationery supplies pur-
22 chased through the Keeper of Stationery, United
23 States Senate,

24 (4) payments to the Postmaster, United States
25 Senate,

1 (5) the payment of metered charges on copying
2 equipment provided by the Office of the Sergeant at
3 Arms and Doorkeeper, United States Senate, or

4 (6) the payment of Senate Recording and
5 Photographic Services.

6 SEC. 5. There are authorized such sums as may be
7 necessary for agency contributions related to the com-
8 pensation of employees of the committee from March 1,
9 1993, through February 28, 1994, and March 1, 1994,
10 through February 28, 1995, to be paid from the
11 Appropriations account for "Expenses of Inquiries and
12 Investigations".
