CONCURRENT RESOLUTION

Authorizing the use of the Capitol Grounds for the
Washington for Jesus 1996 prayer rally.

Whereas One Nation Under God, Inc. has sponsored two previous prayer rallies entitled Washington for Jesus in the city of Washington and plans a third such event over a two-day period on April 29 and 30, 1996;

Whereas public assembly for giving thanks and praying for the United States is a tradition in this Nation dating

from before the Nation's founding and commemorated each year by a national Thanksgiving holiday; and

Whereas the Washington for Jesus prayer rally provides for the peaceable assembly and public expression of peoples of all faiths to pray and give thanks for the United States: Now, therefore, be it

1 *Resolved by the House of Representatives (the Senate*
2 *concurring),*

3 **SECTION. 1. USE OF CAPITOL GROUNDS FOR WASHINGTON**
4 **FOR JESUS 1996 PRAYER RALLY.**

5 (a) IN GENERAL.—One Nation Under God, Inc. (in
6 this resolution referred to as the “sponsor”) shall be per-
7 mitted to sponsor a public event (in this resolution re-
8 ferred to as the “event”) over a two-day period on April
9 29 and 30, 1996 (plus one day before and one day after
10 the event to fully accommodate for setup, takedown, and
11 cleanup).

12 (b) TERMS AND CONDITIONS.—The event shall be
13 free of any admission charge to the public and arranged
14 so as not to interfere with the needs of Congress, subject
15 to conditions to be prescribed by the Architect of the Cap-
16 itol and the Capitol Police Board. The sponsor shall as-
17 sume full responsibility for all expenses and liabilities inci-
18 dent to all activities associated with the event.

19 (c) STRUCTURES AND EQUIPMENT.—For the pur-
20 poses of this resolution, the sponsor is authorized to erect

1 upon the Capitol Grounds such stage, sound amplification
2 devices, and related structures and equipment as may be
3 required to conduct the event, subject to approval of the
4 Architect of the Capitol.

5 (d) ADDITIONAL ARRANGEMENTS.—The Architect of
6 the Capitol and the Capitol Police Board are authorized
7 to make any such additional arrangements as may be nec-
8 essary to carry out the event consistent with good order,
9 public health, safety, and protection of the Capitol and
10 the Capitol Grounds.

11 **SEC. 2. SPONSORSHIP OR ENDORSEMENT.**

12 Nothing contained in this resolution shall be con-
13 strued as an endorsement of the sponsor or the event (or
14 any related activities or expressions, religious or other-
15 wise). The sponsor shall not represent either directly or
16 indirectly that this resolution or any activity carried out
17 under this resolution in any way constitutes approval or
18 endorsement by the United States Government, or any of
19 its agencies, of any activity or expression, religious or oth-
20 erwise, of the sponsor or the event.
