A BILL

For the relief of Nguyen Quy An and Nguyen Ngoc Kim
Quy.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT RESIDENT STATUS FOR NGUYEN**
4 **QUY AN AND NGUYEN NGOC KIM QUY.**

5 (a) ~~IN GENERAL.~~—Notwithstanding subsections (a)
6 and (b) of section 201 of the Immigration and Nationality

1 Act, Nguyen Quy An and Nguyen Ngoc Kim Quy shall
2 each be eligible for issuance of an immigrant visa or for
3 adjustment of status to that of an alien lawfully admitted
4 for permanent residence upon filing an application for is-
5 suance of an immigrant visa under section 204 of such
6 Act or for adjustment of status to lawful permanent resi-
7 dent.

8 (b) ADJUSTMENT OF STATUS.—If Nguyen Quy An
9 or Nguyen Ngoc Kim Quy enters the United States before
10 the filing deadline specified in subsection (c), he or she
11 shall be considered to have entered and remained lawfully
12 and shall, if otherwise eligible, be eligible for adjustment
13 of status under section 245 of the Immigration and Na-
14 tionality Act as of the date of the enactment of this Act.

15 (c) DEADLINE FOR APPLICATION AND PAYMENT OF
16 FEES.—Subsections (a) and (b) shall apply only if the ap-
17 plication for issuance of an immigrant visa or the applica-
18 tion for adjustment of status is filed with appropriate fees
19 within 2 years after the date of the enactment of this Act.

20 (d) REDUCTION OF IMMIGRANT VISA NUMBER.—
21 Upon the granting of an immigrant visa or permanent res-
22 idence to Nguyen Quy An and Nguyen Ngoc Kim Quy,
23 the Secretary of State shall instruct the proper officer to
24 reduce by 2, during the current or next following fiscal
25 year, the total number of immigrant visas that are made

1 available to natives of the country of the aliens' birth
2 under section 203(a) of the Immigration and Nationality
3 Act ~~or~~, if applicable, the total number of immigrant visas
4 that are made available to natives of the country of the
5 aliens' birth under section 202(e) of such Act.

6 **SECTION 1. WAIVER OF CERTAIN NATURALIZATION RE-**
7 **QUIREMENTS FOR NGUYEN QUY AN.**

8 *(a) IN GENERAL.—Notwithstanding the inability of*
9 *Nguyen Quy An to meet the requirements of section 316*
10 *of the Immigration and Nationality Act that relate to hav-*
11 *ing the status of an alien lawfully admitted for permanent*
12 *residence, and residence and physical presence in the Unit-*
13 *ed States, if otherwise qualified he shall be considered eligi-*
14 *ble for naturalization and, upon filing an application for*
15 *naturalization and being administered the oath of renunci-*
16 *ation and allegiance pursuant to section 337 of such Act,*
17 *shall be naturalized as a citizen of the United States.*

18 *(b) DEADLINE FOR APPLICATION AND PAYMENT OF*
19 *FEES.—Subsection (a) shall apply only if the application*
20 *for naturalization is filed with appropriate fees within 2*
21 *years after the date of the enactment of this Act.*
