A BILL

To amend the Portal-to-Portal Act of 1947 relating to the payment of wages to employees who use employer owned vehicles.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PROPER COMPENSATION FOR USE OF EM-**
 4 **PLOYER VEHICLES.**

5 Section 4(a) of the Portal-to-Portal Act of 1947 (29
 6 U.S.C. 254(a)) is amended by striking “and” at the end
 7 of paragraph (1), by striking the period at the end of para-
 8 graph (2) and inserting “; and”, and by adding at the
 9 end the following:

10 “~~(3)~~ use of employer owned vehicles for travel-
 11 ing to and from the actual place of performance of
 12 the principal activity which such employee is em-
 13 ployed to perform.”

14 **SECTION 1. PROPER COMPENSATION FOR USE OF EM-**
 15 **PLOYER VEHICLES.**

16 *Section 4(a) of the Portal-to-Portal Act of 1947 (29*
 17 *U.S.C. 254(a)) is amended by adding at the end the follow-*
 18 *ing: “For purposes of this subsection, the use of an employ-*
 19 *er’s vehicle for travel by an employee and activities per-*
 20 *formed by an employee which are incidental to the use of*
 21 *such vehicle for commuting shall not be considered part of*
 22 *the employee’s principal activities if the use of such vehicle*
 23 *for travel is within the normal commuting area for the em-*
 24 *ployer’s business or establishment and the use of the employ-*
 25 *er’s vehicle is subject to an agreement on the part of the*

1 *employer and the employee or representative of such em-*
2 *ployee.”.*

3 **SEC. 2. EFFECTIVE DATE.**

4 *The amendment made by section 1 shall take effect on*
5 *the date of the enactment of this Act and shall apply in*
6 *determining the application of section 4 of the Portal-to-*
7 *Portal Act of 1947 to an employee in any civil action*
8 *brought before such date of enactment but pending on such*
9 *date.*
