**A BILL**

To combat crime by enhancing the penalties for certain sexual crimes against children.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Sexual Crimes Against*  
3 *Children Prevention Act of 1995”.*

4 **SEC. 2. INCREASED PENALTIES FOR CERTAIN CONDUCT IN**  
5 **SEXUAL EXPLOITATION OF CHILDREN.**

6 *The United States Sentencing Commission shall*  
7 *amend the sentencing guidelines to increase the base offense*  
8 *level for offenses under section 2251 or 2252 of title 18,*  
9 *United States Code, by at least 2 levels.*

10 **SEC. 3. INCREASED PENALTIES FOR USE OF COMPUTERS IN**  
11 **SEXUAL EXPLOITATION OF CHILDREN.**

12 *The United States Sentencing Commission shall*  
13 *amend the sentencing guidelines with respect to an offense*  
14 *under—*

15 *(1) section 2251(c)(1)(A); or*

16 *(2) any of paragraphs (1) through (3) of section*  
17 *2252(a);*

18 *of title 18, United States Code, to increase the offense level*  
19 *by at least 2 levels if a computer was used to transmit the*  
20 *notice or advertisement to the intended recipient or to*  
21 *transport or ship the visual depiction.*

22 **SEC. 4. INCREASED PENALTIES FOR TRANSPORTATION OF**  
23 **CHILDREN WITH INTENT TO ENGAGE IN**  
24 **CRIMINAL SEXUAL ACTIVITY.**

25 *The United States Sentencing Commission shall*  
26 *amend the sentencing guidelines to increase the base offense*

1 *level for an offense under section 2423(a) of title 18, United*  
2 *States Code, by at least 3 levels.*

3 **SEC. 5. PREDICATE OFFENSES FOR RICO.**

4 *Section 1961(1)(B) of title 18, United States Code, is*  
5 *amended by striking “sections 1461–1465 (relating to ob-*  
6 *scene matter)” and inserting “chapter 71 (relating to ob-*  
7 *scenity)”.*

8 **SEC. 6. TECHNICAL CORRECTION.**

9 *Section 2423(b) of title 18, United States Code, is*  
10 *amended by striking “2245” and inserting “2246”.*

11 **SEC. 7. REPORT BY THE UNITED STATES SENTENCING COM-**  
12 **MISSION.**

13 *Not later than 180 days after the date of the enactment*  
14 *of this Act, the United States Sentencing Commission shall*  
15 *submit a report to Congress concerning offenses involving*  
16 *child pornography and other sexual crimes against chil-*  
17 *dren. In this report the Commission shall include—*

18 *(1) an analysis of the sentences imposed for of-*  
19 *fenses under sections 2251, 2252, and 2423 of title 18,*  
20 *United States Code, and recommendations as to any*  
21 *modifications to the sentencing guidelines that may*  
22 *be appropriate with respect to those offenses;*

23 *(2) an analysis of the sentences imposed for of-*  
24 *fenses under sections 2241, 2242, 2243, and 2244 of*  
25 *title 18, United States Code, where the victim was*

1     *under the age of 18 years, and recommendations as*  
2     *to any modifications to the sentencing guidelines that*  
3     *may be appropriate with respect to those offenses;*

4             *(3) an analysis of the type of substantial assist-*  
5     *ance that courts have recognized as warranting a*  
6     *downward departure from the sentencing guidelines*  
7     *relating to offenses under section 2251 or 2252 of title*  
8     *18, United States Code;*

9             *(4) a survey of the recidivism rate for offenders*  
10    *convicted of committing sexual crimes against chil-*  
11    *dren, an analysis of the impact on recidivism of sex-*  
12    *ual abuse treatment provided during or after incar-*  
13    *ceration or both, and an analysis of whether increased*  
14    *penalties would reduce recidivism for these crimes;*  
15    *and*

16            *(5) such other recommendations with respect to*  
17    *the offenses described in this section as the Commis-*  
18    *sion deems appropriate.*
