## A BILL

To rename the San Francisco Bay National Wildlife Refuge as the Don Edwards San Francisco Bay National Wildlife Refuge.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SAN FRANCISCO BAY NATIONAL WILDLIFE REF-**  
4                                    **UGE RENAMED AS DON EDWARDS SAN FRAN-**  
5                                    **CISCO BAY NATIONAL WILDLIFE REFUGE.**

6        (a) REFUGE RENAMED.—The San Francisco Bay  
7 National Wildlife Refuge (established by the Act entitled  
8 “An Act to provide for the establishment of the San Fran-  
9 cisco Bay National Wildlife Refuge”, approved June 30,  
10 1972 (86 Stat. 399 et seq.)), is hereby renamed and shall  
11 be known as “the Don Edwards San Francisco Bay Na-  
12 tional Wildlife Refuge”.

13        (b) REFERENCES.—Any reference in any statute,  
14 rule, regulation, Executive order, publication, map, or  
15 paper or other document of the United States to the San  
16 Francisco Bay National Wildlife Refuge is deemed to refer  
17 to the Don Edwards San Francisco Bay National Wildlife  
18 Refuge.

19        (c) CONFORMING AMENDMENT.—The Act entitled  
20 “An Act to provide for the establishment of the San Fran-  
21 cisco Bay National Wildlife Refuge”, approved June 30,  
22 1972 (86 Stat. 399 et seq.), is amended by striking “San  
23 Francisco Bay National Wildlife Refuge” each place it ap-  
24 pears and inserting “Don Edwards San Francisco Bay  
25 National Wildlife Refuge”.
