A BILL

For the relief of Norton R. Girault.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. WAIVER OF TIME LIMITATIONS.**

4 The time limitations set forth in section 3702(b) of
5 title 31, United States Code, shall not apply with respect
6 to a claim for the disbursement of pay due by the Depart-
7 ment of the Navy to Norton R. Girault, United States
8 Navy (retired), of Norfolk, Virginia. The amounts due are

1 represented by the following checks that were received but
2 not negotiated by Norton R. Girault:

6 the amount of \$531.00 for salary and expenses.

7 (21) Treasury check number 6,368,406, dated
8 January 25, 1968, in the amount of \$525.00 for sal-
9 ary and expenses.

10 **SEC. 2. DEADLINE.**

11 Section 1 shall apply only if Norton R. Girault or
12 his authorized representative submits a claim pursuant to
13 such subsection before the expiration of the 1-year period
14 beginning on the date of the enactment of this Act.
