6 Ysleta in El Paso, Texas, shall be known and designated  
7 as the “Timothy C. McCaghren Customs Administrative  
8 Building”.

9 **SEC. 2. REFERENCES.**

10 Any reference in a law, map, regulation, document,  
11 paper, or other record of the United States to the building  
12 referred to in section 1 shall be deemed to be a reference  
13 to the “Timothy C. McCaghren Customs Administrative  
14 Building”.

15 **SECTION 1. DESIGNATION.**

16 *The United States Customs Administrative Building*  
17 *at the Ysleta/Zaragosa Port of Entry located at 797 South*  
18 *Zaragosa Road in El Paso, Texas, shall be known and des-*  
19 *ignated as the “Timothy C. McCaghren Customs Adminis-*  
20 *trative Building”.*

21 **SEC. 2. REFERENCES.**

22 *Any reference in a law, map, regulation, document,*  
23 *paper, or other record of the United States to the building*  
24 *referred to in section 1 shall be deemed to be a reference*
