1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SECTION 1. CONVERSION TO PERMANENT LAW OF MODEL**  
2 **GOOD SAMARITAN FOOD DONATION ACT AND**  
3 **TRANSFER OF THAT ACT TO CHILD NUTRI-**  
4 **TION ACT OF 1966.**

5 (a) CONVERSION TO PERMANENT LAW.—Title IV of  
6 the National and Community Service Act of 1990 is  
7 amended—

8 (1) by striking sections 401 and 403 (42 U.S.C.  
9 12671 and 12673); and

10 (2) in section 402 (42 U.S.C. 12672)—

11 (A) in the section heading, by striking  
12 “**MODEL**” and inserting “**BILL EMERSON**”;

13 (B) in subsection (a), by striking “Good  
14 Samaritan” and inserting “Bill Emerson Good  
15 Samaritan”; and

16 (C) in subsection (c)—

17 (i) by striking “A person or gleaner”  
18 and inserting the following:

19 “(1) LIABILITY OF PERSON OR GLEANER.—A  
20 person or gleaner”;

21 (ii) by striking “needy individuals,”  
22 and inserting “needy individuals.”;

23 (iii) by inserting after “needy individ-  
24 uals.” (as added by clause (ii)) the follow-  
25 ing:

1           “(2) LIABILITY OF NONPROFIT ORGANIZA-  
2           TION.—A nonprofit organization shall not be subject  
3           to civil or criminal liability arising from the nature,  
4           age, packaging, or condition of apparently whole-  
5           some food or an apparently fit grocery product that  
6           the nonprofit organization received as a donation in  
7           good faith from a person or gleaner for ultimate dis-  
8           tribution to needy individuals.”; and

9                           (iv) by striking “except that this para-  
10                          graph” and inserting the following:

11                       “(3) EXCEPTION.—Paragraphs (1) and (2)”.

12           (b) TRANSFER TO CHILD NUTRITION ACT OF  
13           1966.—Section 402 of the National and Community Serv-  
14           ice Act of 1990 (42 U.S.C. 12672) (as amended by sub-  
15           section (a))—

16                       (1) is transferred from the National and Com-  
17                       munity Service Act of 1990 to the Child Nutrition  
18                       Act of 1966;

19                       (2) is redesignated as section 22 of the Child  
20                       Nutrition Act of 1966; and

1           (3) is added at the end of such Act.
