A BILL

To make clerical and technical amendments to title 18,
United States Code, and other provisions of law relating
to crime and criminal justice.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Criminal Law Tech-
5 nical Amendments Act of 1995”.

6 **SEC. 2. GENERAL TECHNICAL AMENDMENTS.**

7 (a) FURTHER CORRECTIONS TO MISLEADING FINE
8 AMOUNTS AND RELATED TYPOGRAPHICAL ERRORS.—

9 (1) Sections 152, 153, 154, and 610 of title 18,
10 United States Code, are each amended by striking

1 “fined not more than \$5,000” and inserting “fined
2 under this title”.

3 (2) Section 970(b) of title 18, United States
4 Code, is amended by striking “fined not more than
5 \$500” and inserting “fined under this title”.

6 (3) Sections 661, 1028(b), 1361, and 2701(b)
7 of title 18, United States Code, are each amended
8 by striking “fine of under” each place it appears and
9 inserting “fine under”.

10 (4) Section 3146(b)(1)(A)(iv) of title 18, Unit-
