A BILL

To provide for the conveyance of certain land to the Del
Norte County Unified School District of Del Norte Coun-
ty, California.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. CONVEYANCE.**

2 *As soon as practicable after the date of the enactment*
3 *of this Act, the Secretary of Agriculture shall convey to the*
4 *Del Norte County Unified School District of Del Norte*
5 *County, California, in accordance with this Act, all right,*
6 *title, and interest of the United States in and to the prop-*
7 *erty described in section 2.*

8 **SEC. 2. PROPERTY DESCRIPTION.**

9 *The property referred to in section 1 is that portion*
10 *of Township 17 North, Range 2 East, Humboldt Meridian*
11 *in Del Norte County, California, which is further described*
12 *as follows:*

13 *Beginning at Angle Point No. 3 of Tract 41 as*
14 *resurveyed by the Bureau of Land Management under*
15 *survey Group No. 1013, approved August 13, 1990,*
16 *and shown on the official plat thereof;*

17 *thence on the line between Angle Points No. 3*
18 *and No. 4 of Tract 41, North 89 degrees, 24 minutes,*
19 *20 seconds East, a distance of 345.44 feet to Angle*
20 *Point No. 4 of Tract 41;*

21 *thence on the line between Angle Points No. 4*
22 *and No. 5 of Tract 41, South 00 degrees, 01 minutes,*
23 *20 seconds East, a distance of 517.15 feet;*

24 *thence West, a distance of 135.79 feet;*

25 *thence North 88 degrees, 23 minutes, 01 seconds*
26 *West, a distance of 61.00 feet;*

1 *thence North 39 degrees, 58 minutes, 18 seconds*
2 *West, a distance of 231.37 feet to the East line of Sec-*
3 *tion 21, Township 17 North, Range 2 East;*

4 *thence along the East line of Section 21, North*
5 *00 degrees, 02 minutes, 20 seconds West, a distance*
6 *of 334.53 feet to the point of beginning.*

7 **SEC. 3. CONSIDERATION.**

8 *The conveyance provided for in section 1 shall be with-*
9 *out consideration except as required by this Act.*

10 **SEC. 4. CONDITIONS OF CONVEYANCE.**

11 *The conveyance provided for in section 1 shall be sub-*
12 *ject to the following conditions:*

13 (1) *Del Norte County shall be provided, for no*
14 *consideration, an easement for County Road No. 318*
15 *which crosses the Northeast corner of the property*
16 *conveyed.*

17 (2) *The Pacific Power and Light Company shall*
18 *be provided, for no consideration, an easement for*
19 *utility equipment as necessary to maintain the level*
20 *of service provided by the utility equipment on the*
21 *property as of the date of the conveyance.*

22 (3) *The United States shall be provided, for no*
23 *consideration, an easement to provide access to the*
24 *United States property that is south of the property*
25 *conveyed.*

1 **SEC. 5. LIMITATIONS ON CONVEYANCE.**

2 *The conveyance authorized by section 1 is subject to*
3 *the following limitations:*

4 (1) *ENCUMBRANCES.*—*Such conveyance shall be*
5 *subject to all encumbrances on the land existing as of*
6 *the date of enactment of this Act.*

7 (2) *RE-ENTRY RIGHT.*—*The United States shall*
8 *retain a right of re-entry in the land described for*
9 *conveyance in section 2. If the Secretary determines*
10 *that the conveyed property is not being used for pub-*
11 *lic educational or related recreational purposes, the*
12 *United States shall have a right to re-renter the prop-*
13 *erty conveyed therein without consideration.*

14 **SEC. 6. ADDITIONAL TERMS AND CONDITIONS.**

15 *The conveyance provided for in section 1 shall be sub-*
16 *ject to such additional terms and conditions as the Sec-*
17 *retary of Agriculture and the Del Norte County Unified*
18 *School District agree are necessary to protect the interests*
19 *of the United States.*
