## A BILL

To direct the Administrator of the Federal Aviation Administration to develop a system for collecting and disseminating information concerning the quality of aircraft pilot performances in training activities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Aircraft Pilot Safety  
5 Act of 1995”.

1 **SEC. 2. AIRCRAFT PILOT REPORTING SYSTEM.**

2 (a) IN GENERAL.—Not later than 180 days after the  
3 date of the enactment of this Act, the Administrator, in  
4 consultation with covered air carriers, pilots, and other in-  
5 terested persons, shall develop an aircraft pilot reporting  
6 system in accordance with the requirements of this sec-  
7 tion.

8 (b) REQUIREMENTS.—As part of the aircraft pilot re-  
9 porting system, the Administrator shall—

10 (1) require all covered air carriers and inde-  
11 pendent facilities that train pilots for such air car-  
12 riers—

13 (A) to maintain standardized information  
14 on the quality of pilot performances in training  
15 activities;

16 (B) to use such information to ensure the  
17 quality of pilot performances and the quality of  
18 the training program; and

19 (C) to provide such information to the Ad-  
20 ministrator;

21 (2) establish a storage and retrieval system for  
22 information that is provided to the Administrator  
23 pursuant to paragraph (1)(C); and

24 (3) require all covered air carriers to obtain in-  
25 formation from the storage and retrieval system for

1 the purpose of evaluating applicants for pilot posi-  
2 tions during the pilot selection and hiring process.

3 (c) **PRIVACY PROTECTIONS.**—In establishing the air-  
4 craft pilot reporting system, the Administrator shall en-  
5 sure that the system includes measures to protect the pri-  
6 vacy concerns of individual aircraft pilots, including—

7 (1) procedures for obtaining the permission of  
8 a pilot before releasing information about the pilot;  
9 and

10 (2) procedures to provide a pilot with sufficient  
11 access to information about the pilot to ensure the  
12 accuracy of the information.

13 **SEC. 3. RECOMMENDATIONS TO CONGRESS.**

14 (a) **IN GENERAL.**—Not later than 120 days after the  
15 date of the enactment of this Act, the Administrator shall  
16 transmit to Congress a report containing a description of  
17 the aircraft pilot reporting system, together with—

18 (1) an estimate of the costs associated with im-  
19 plementation of the system;

20 (2) recommendations concerning administration  
21 of the system by a private entity; and

22 (3) recommendations for any additional legisla-  
23 tive or administrative actions.

24 (b) **RECOMMENDATIONS ON AIR CARRIER LIABIL-**  
25 **ITY.**—As part of the report to be transmitted under sub-

1 section (a), the Administrator shall include recommenda-  
2 tions for legislative actions and other measures to limit  
3 the liability of covered air carriers and other persons par-  
4 ticipating in the aircraft pilot reporting system with re-  
5 spect to the participation of such persons in the system.

6 (c) IMPLEMENTATION.—The Administrator may  
7 begin to implement the aircraft pilot reporting system only  
8 if the system is approved by a law enacted after the date  
9 of the enactment of this Act.

10 **SEC. 4. DEFINITIONS.**

11 In this Act, the following definitions apply:

12 (1) ADMINISTRATOR.—The term “Adminis-  
13 trator” means the Administrator of the Federal  
14 Aviation Administration.

15 (2) AIRCRAFT PILOT REPORTING SYSTEM.—The  
16 term “aircraft pilot reporting system” means the re-  
17 porting system to be developed under section 2.

18 (3) COVERED AIR CARRIER.—The term “cov-  
19 ered air carrier” means an air carrier operating  
20 under parts 121 and 135 of title 14, Code of Fed-  
21 eral Regulations, as in effect on the date of the en-  
22 actment of this Act.

23 (4) TRAINING ACTIVITIES.—The term “training  
24 activities” means activities that the Administrator  
25 determines assess the skills, abilities, knowledge, and

- 1 judgment of a pilot during training, check flights,
- 2 initial operating experience, and line checks.
