**AN ACT**

To accept the request of the Prairie Island Indian Community to revoke their charter of incorporation issued under the Indian Reorganization Act.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REVOCATION OF CHARTER OF INCORPORATION OF THE PRAIRIE ISLAND INDIAN COMMUNITY UNDER THE INDIAN REORGANIZATION ACT.**

5 The request of the Prairie Island Indian Community  
6 to surrender the charter of incorporation issued to that  
7 Community on July 23, 1937, pursuant to section 17 of  
8 the Act of June 18, 1934, commonly known as the “Indian  
9 Reorganization Act” (25 U.S.C. 477) is hereby accepted  
10 and that charter of incorporation is hereby revoked.

11 **SECTION 1. REVOCATION OF CHARTER OF INCORPORATION**  
12 **OF THE PRAIRIE ISLAND INDIAN COMMUNITY**  
13 **UNDER THE INDIAN REORGANIZATION ACT.**

14 (a) *ACCEPTANCE OF REQUEST TO REVOKE CHARTER.*—*The request of the Prairie Island Indian Community*  
15 *to surrender the charter of incorporation issued to that com-*  
16 *munity on July 23, 1937, pursuant to section 17 of the*  
17 *Act of June 18, 1934, commonly known as the “Indian Re-*  
18 *organization Act” (48 Stat. 988, chapter 576; 25 U.S.C.*  
19 *477) is hereby accepted.*

21 (b) *REVOCATION OF CHARTER.*—*The charter of incor-*  
22 *poration referred to in subsection (a) is hereby revoked.*

23 **SEC. 2. AMENDMENT TO THE JICARILLA APACHE TRIBE**  
24 **WATER RIGHTS SETTLEMENT ACT.**

25 Section 8(e)(3) *The Jicarilla Apache Tribe Water*  
26 *Rights Settlement Act (106 Stat. 2241) is amended by strik-*

1 *ing “December 31, 1996” and inserting “December 31,*  
2 *1998”.*

3 **SEC. 3. AMENDMENT TO THE SAN CARLOS APACHE TRIBE**

4 **WATER RIGHTS SETTLEMENT ACT OF 1992.**

5 *Section 3711(b)(1) of the San Carlos Apache Tribe*  
6 *Water Rights Settlement Act of 1992 (106 Stat. 4752) is*  
7 *amended by striking “December 31, 1996” and inserting*  
8 *“June 30, 1997”.*
