A BILL

To amend title XVIII of the Social Security Act to permit the geographic reclassification of hospitals for purposes of disproportionate share hospital payment adjustments under the Medicare program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. MEDICARE HOSPITAL GEOGRAPHIC RECLASSI-**
2 **FICATION PERMITTED FOR PURPOSES OF**
3 **DISPROPORTIONATE SHARE PAYMENT AD-**
4 **JUSTMENTS.**

5 (a) IN GENERAL.—Section 1886(d)(10)(C)(i) of the
6 Social Security Act (42 U.S.C. 1395ww(d)(10)(C)(i)) is
7 amended—

8 (1) by striking “or” at the end of subclause (I);

9 (2) by striking the period at the end of sub-
10 clause (II) and inserting “, or”;

11 (3) by inserting after subclause (II) the follow-
12 ing:

13 “(III) eligibility for and amount of additional
14 payment amounts under paragraph (5)(F).”; and

15 (4) by adding at the end the following:

16 “Any application approved for purposes of subclause (I)
17 for a fiscal year is deemed to be approved for purposes
18 of subclause (III) for that fiscal year.”.

19 (b) EFFECTIVE DATE.—

20 (1) IN GENERAL.—The amendments made by
21 subsection (a) shall apply to discharges occurring on
22 or after October 1, 1996.

23 (2) TREATMENT.—The amendment made by
24 subsection (a)(4) shall apply regardless of when an
25 approval of reclassification for purposes of section

1 1886(d)(10)(C)(i)(I) of the Social Security Act oc-
2 curs.

3 (c) TRANSITION FOR FISCAL YEAR 1997.—

4 (1) IN GENERAL.—A hospital that seeks reclas-
5 sification under section 1886(d)(10)(C)(i)(III) of the
6 Social Security Act for fiscal year 1997 shall be per-
7 mitted to submit an application for such reclassifica-
8 tion by not later than 60 days after the date of the
9 enactment of this Act.

10 (2) RECONSIDERATION OF CURRENT APPLICA-
11 TIONS.—In the case of an application of a hospital
12 for reclassification under section
13 1886(d)(10)(C)(i)(I) of such Act that was submitted
14 before the date of the enactment of this Act and
15 that is pending or was denied as of such date, the
16 application shall be treated as an application de-
17 scribed in paragraph (1) if the hospital submits a
18 written request for treatment under this paragraph
19 to the Medicare Geographic Classification Review
20 Board not later than 60 days after the date of the
21 enactment of this Act.
