3 **SECTION 1. DIFFERENTIATION AMONG FATS, OILS, AND**

5 ~~(a) IN GENERAL.—In issuing or enforcing any regu-~~

7 ~~ing to a fat, oil, or grease under any Federal law, the head~~

3        **SEC. 3. DIFFERENTIATION AMONG FATS, OILS, AND**  
4        **GREASES.**

5        *(a) IN GENERAL.—In issuing or enforcing a regula-*  
6        *tion, an interpretation, or a guideline relating to a fat, oil,*  
7        *or grease under a Federal law, the head of a Federal agency*  
8        *shall—*

9                *(1) differentiate between and establish separate*  
10        *categories for—*

11                        *(A)(i) animal fats; and*

12                        *(ii) vegetable oils; and*

13                        *(B) other oils, including petroleum oil; and*

14                *(2) apply different standards to different classes*  
15        *of fat and oil as provided in subsection (b).*

16        *(b) CONSIDERATION.—In differentiating between the*  
17        *classes of animal fats and vegetable oils referred to in sub-*  
18        *section (a)(1)(A) and the classes of oils described in sub-*  
19        *section (a)(1)(B), the head of the Federal agency shall con-*  
20        *sider differences in physical, chemical, biological, and other*  
21        *properties, and in the effects on human health and the envi-*  
22        *ronment, of the classes.*

23        **SEC. 4. FINANCIAL RESPONSIBILITY.**

24        *(a) LIMITS OF LIABILITY.—Section 1004(a)(1) of the*  
25        *Oil Pollution Act of 1990 (33 U.S.C. 2704(a)(1)) is amend-*

1 *ed by striking “for a tank vessel,” and inserting “for a tank*  
2 *vessel (other than a tank vessel carrying animal fat or vege-*  
3 *table oil),”.*

4 *(b) FINANCIAL RESPONSIBILITY.—The first sentence of*  
5 *section 1016(a) of the Act (33 U.S.C. 2716(a)) is amended*  
6 *by striking “in the case of a tank vessel,” and inserting*  
7 *“in the case of a tank vessel (other than a tank vessel carry-*  
8 *ing animal fat or vegetable oil),”.*

25 **oils from the seeds, nuts, and kernels re-**

1       **ferred to in paragraph (1)(A) of such sec-**  
2       **tion; and**

3               **(2) other oils and greases, including**  
4       **petroleum.**

5       **(b) CONSIDERATIONS.—In differentiating**  
6       **between the class of fats, oils, and greases de-**  
7       **scribed in subsection (a)(1) and the class of**  
8       **oils and greases described in subsection**  
9       **(a)(2), the head of the Federal agency shall**  
10       **consider differences in the physical, chemical,**  
11       **biological, and other properties, and in the**  
12       **environmental effects, of the classes.**
